

CHAPTER 11 OF THE BANKRUPTCY CODE**

I, DORON EZRA, do hereby certify as follows:

1. I am the Chairman of the Board of Directors of Overland Direct Gaon, Inc., (the "Company").

2. At a special meeting of the Company's Board of Directors (the "Board") held on August 21, 2009, the following resolutions were duly enacted by a unanimous vote of the Board, and the same remain in full force and effect, without modification, as of the date hereof:






