CONSENT AND AGREEMENT OF THE SOLE MEMBER OF ARI-RC 12, LLC TO COMMENCEMENT OF CHAPTER 11 BANKRUPTCY PROCEEDING

The undersigned, Brauburger Investment Corp. (hereinafter, the "Member"), being the sole member and owning 100% of the membership interest in ARI-RC 12, LLC, a Delaware limited liability company (the "Company"), hereby declares, consents and agrees as follows:
