



The discussion included consideration of various legal options, debt settlement options, and liquidation of assets. In light of the short time remaining before complete loss of company assets, a determination was made that a Chapter 11 Bankruptcy petition should be filed.

Whereas: The Company is unable to pay its debts as said debts mature, the following resolution has been made:

Resolved that: The officers of this company are hereby authorized and directed on behalf of the Company to prepare, file and execute the Company's Petition for Bankruptcy as provided in Chapter 11 of the US Bankruptcy Code along with all of the necessary papers in connection therewith, to be filed in the United States Bankruptcy Court, Central District of California, and the officers shall do any acts, execute all necessary documents, and take such other steps in the name of and on behalf of the Company necessary or appropriate to obtaining such relief afforded in the Bankruptcy Court. The officers are further authorized to retain as counsel for the Company in said proceeding, the legal services of Kent Salveson, attorney at law.

The resolution was voted on and unanimously approved.




