22 Pursuant to Federal Rules of Bankruptcy Procedure 207.2(c) and the order directing this
23 appointment entered by this Court on May 24, 2016, Constance Doyle was duly appointed as
24 the Patient Care Ombudsman (PCO) for Long-Dei Liu. ("Debtor") in this case. In accordance
25 with Section 333(b)(2) this seventh interim report (the Seventh Interim Report") is hereby
26 respectfully submitted for the period of May 1, 2017 through June 30, 2017.

1 **I. INTRODUCTION**

2 On May 9, 2016, the Court approved the appointment of a Patient Care Ombudsman
3 in this case. On May 11, 2016, the Notice of Appointment of Constance R Doyle as Patient
4 Care Ombudsman under 11 U.S.C. § section 333(b) (2) was filed. The order approving the
5 Appointment was signed May 24, 2016. As set forth in the Order and the Appointment
6 Notice, the Ombudsman was appointed to monitor the quality of patient care provided by the
7 Debtor, to the extent necessary under the circumstances, including interviewing
8 patients/clients, administration, staff, physicians and other interested parties. Further to the
9 Order and the Notice of Appointment, a review of confidential documents as provided by the
10 Debtor, including patient/client records occurred. As per compliance with the Notice of
11 Appointment, and the Order, no professionals or any other entities for assistance in the
12 process were sought, accepting the assignment as a non-conflict of interest individual
13 regarding the Debtors and other key individuals. Additionally, as per compliance with the
14 Notice of Appointment, a one-page Notice was posted at the office of “Long-Dei Liu, MD”,
15 Garden Grove, CA., the place of business of the Debtor with contact information for the
16 Ombudsman allowing for concerns and/or issues to be discussed. Copy submitted with 1st
17 Report.

18 Background information is reported as:

19 Long-Dei Liu, MD, (Debtor) has practiced Obstetrics and Gynecology since 1981. He
20 has been at the current Garden Grove, CA location since 1999 and is Board Certified in
21 OB/GYN. This is a single practitioner with one Office Manager who does both front and
22 back office duties. Dr. Liu is affiliated with 2 Hospitals (Fountain Valley and South Coast
23 Global in Santa Ana) where all his deliveries occur.

24 **II. SUMMARY OF PCO OBSERVATIONS AT THE MEDICAL**
25 **OFFICE OF LONG-DEI LIU, GARDEN GROVE, CA.**

1 **MAY 2017**

2 Practice continues as previously reported with 2-4 deliveries per month and
3 gynecology patients. Dr. Liu maintains his Continuing Medical Education (CME) as is
4 required for license and Board status.

5 Waiting for the Appeals Court date for the civil action. Patients observed have always
6 been pleased with the care received. No issues identified.

7 **JUNE 2017**

8 No changes to report. The practice continues with both gynecology and obstetrics.
9 Dr. Liu monthly deliveries are 2-4, with 4 deliveries in May. Patient present for AM
10 appointment.

11 No issues identified.

12 **III. CONCLUSION**

13 The Patient Care Ombudsman (PCO) finds that all care provided to the patients by
14 Long-Dei Liu, M.D. is well within the standard of care.

15 The PCO will continue to monitor and is available to respond to any concerns or
16 questions of the Court or interested party.
