22	IT IS HEREBY STIPULATED AND AGREED between RESCUE ONE AMBULANCE				
23	(the "Debtor") and the UNITED STATES OF AMERICA, on behalf of its agency, the				
24	INTERNAL REVENUE SERVICE, through their respective counsel, as follows:				
25	1. This stipulation supplements the Stipulation for Use of Cash Collateral filed at				
26	Docket No. 16 (the "Stipulation"), and approved by	court order on January 13 ,2017.			
27	2. All of the terms set forth in the Stipu	lation filed at Docket No. 16 remain in effect.

- 3. On February 18, 2016, Debtor previously filed a voluntary chapter 11 bankruptcy petition, case number 2:16-bk-12012-NB ("2016 Bankruptcy").
- 4. In the 2016 Bankruptcy, the IRS filed a proof of claim in the total amount of \$1,411,821.03 (Claim No. 1-1), comprised of a secured claim in the amount of \$686,905.58, an unsecured priority claim of \$721,008.46, and a general unsecured claim in the amount of \$3,906.99.
- 5. The IRS recorded Notices of Federal Tax Lien ("NFTL"), covering the tax liabilities for the periods stated in the proof of claim, with the Secretary of State, as follows:

  - 8. On January 17, 2017, the Debtor filed its schedules.
- 9. On January 25, 2017, the IRS filed a proof of claim in the total amount of \$878,827.92 (Claim No. 6-1), comprised of a secured claim in the amount of \$659,409.41, an unsecured priority claim of \$202,371.73, and a general unsecured claim in the amount of \$17,046.78.
  - 10. January 30, 2017, the Debtor filed amended schedules.
- 11. On February 6, 2017, the United States Trustee held the initial 341(a) meeting. The Debtor did not appear. The United States Trustee set a continued 341(a) meeting for March 8, 2017.
- 12. On February 14, 2017, the IRS filed an amended proof of claim in the total amount of \$873,160.87 (Claim No. 6-2), comprised of a secured claim in the amount of \$659,409.41, an unsecured priority claim of \$193,800.40, and a general unsecured claim in the amount of \$19,951.06.
- 13. On February 22, 2017, the IRS filed an amended proof of claim in the total amount of \$878,827.92 (Claim No. 6-3), comprised of a secured claim in the amount of
