23 On October 26, 2017 at 2:00 pm in Courtroom 301 of the above-entitled Bankruptcy  
24 Court located at 21041 Burbank Blvd., Woodland Hills, CA 91367, the hearing on AAA Nursing  
25 Services Inc., the Debtor and Debtor-in-Possession (hereinafter the "Debtor"), in the above-  
26 captioned Chapter 11 case, Motion for an Order Approving the Emergency Interim Use of Cash  
27 Collateral [docket #7] took place.

1 The appearances were waived. The Court orally adopted its tentative ruling approving  
2 Debtor's cash collateral on an interim basis as follows:


3 **IT IS ORDERED THAT** with the exception of the payment of insider compensation,  
4 the Court will authorize the continued use of cash collateral, pursuant to the terms stated in the  
5 *Order Granting Debtor's Emergency Motion for an Order Authorizing Interim Use of Cash*  
6 *Collateral* [docket #32]. In addition, the Court will authorize the use of cash collateral for  
7 "Business Gifts" as set forth in the debtor's budget, ***provided that*** the Debtor must set forth in  
8 each monthly operating report: (1) a description of each business gift made during that month;  
9 (2) the recipient of each business gift; and (3) the amount of each business gift.

10 **IT IS FURTHER ORDER** that the continued hearing on the Motion, *regarding the use*  
11 *of cash collateral to pay insider compensation*, is set for **November 16, 2017 at 2:00 p.m.**

12 **IT IS SO ORDERED.**
