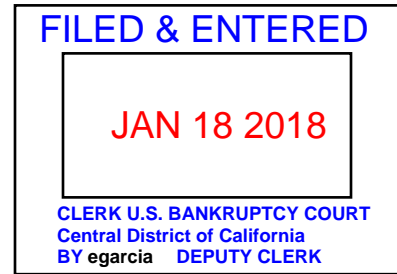

6 through and including February 15, 2018.


7 THE COURT FURTHER ORDERS THAT the Court will hold a final hearing on the
