25 4. A hearing on whether the Debtor may use cash collateral subsequent to
26 September 30, 2018 will take place on September 12, 2018 at 10:00 a.m.

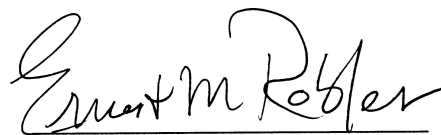
