

20 The hearing on the adequacy of the First Amended Disclosure Statement, filed by  
21 chapter 11 debtor and debtor-in-possession Famoso Porterville, LLC, (the "Debtor"),  
22 came regularly for hearing, appearances were made as noted on the record, the Honorable  
23 Maureen A. Tighe, presiding. The Court having found good cause and notice appearing  
24 proper, hereby Orders as follows:

- 25 1. The Debtor's Disclosure Statement, conditioned upon amendments requested  
26 by the United States Trustee made on the record at the time of hearing, is  
27 hereby approved.

2. The deadline for the Debtor to serve the notice of the Chapter 11 Confirmation Hearing and chapter 11 plan ballots is February 14, 2018.
3. The deadline by which ballots to accept or reject the Debtor's Second Amended Chapter 11 Plan must be returned to, and received by, counsel to the Debtor, is March 21, 2018.
4. The deadline by which any party objecting to confirmation of the Debtor's Second Amended Chapter 11 Plan must file and serve its objections, and evidence in support thereof, shall be March 21, 2018.
5. The deadline for the Debtor to file its ballot tally, confirmation brief and evidence in support thereof, shall be April 11, 2018.
6. The deadline to file responses to the Debtor's confirmation brief shall be April 17, 2018.
7. The chapter 11 plan confirmation hearing shall be held on April 25, 2018, commencing at 9:30 a.m.
