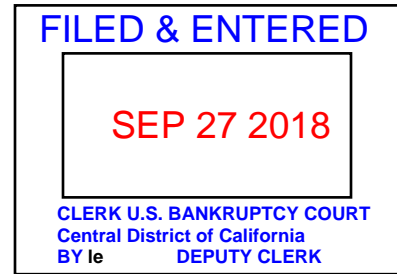

6 Appearances were made as noted on the record.


7 The Court having read and considered the Motion and the related pleadings, heard the statements
