Pursuant to the order directing this appointment entered by this Court on May 1, 2018, Tamar Terzian was duly appointed Patient Care Ombudsman (PCO) for Advanced Specialty Care, (the "<u>Debtor</u>"). On May 9, 2018, Tamar Terzian filed a notice of acceptance of appointment as the PCO to this matter. In accordance with Section 333(b)(2) this second interim report (the "<u>Third Interim Report</u>") is hereby respectfully submitted for the period August 15, 2018 to October 15, 2018.

## I. <u>INTRODUCTION</u>

On May 3, 2018, the Notice of Appointment of Tamar Terzian as Patient Care Ombudsman under 11 U.S.C. § section 333(b)(2) was filed. Debtors counsel and the Office of United States Trustee had entered into a stipulation with an order approving the appointment a PCO on May 1, 2018.

As set forth in the Order and the Appointment Notice, the Ombudsman was appointed to monitor the quality of patient care provided by the Debtors, to the extent necessary under the circumstances, including the interview of patients/clients, administration, staff, and other interested parties. As per compliance with the Notice of Appointment, and the Order, no professionals or any other entities for assistance in the process were sought, accepting the assignment as a non-conflict of interest individual regarding the Debtors and other key individuals. Additionally, as per compliance with the Notice of Appointment, a one-page Notice was posted at the Debtors place of business with contact information for the Ombudsman allowing for concerns and/or issues to be discussed. In addition, the PCO has provided her contact information for each patients family based on each site visit.

## II. BACKGROUND OF THE DEBTOR

The Debtor provides home health care for primarily pediatric patients. The patients are referred primarily from private pediatric doctors or Children's Hospital. The offices are located in mid-Wilshire Los Angeles, but the registered nurses and LVN's are sent to the homes of patients. The Debtor has approximately 150 nurses that cover various shifts both weekdays and weekends.

The Debtor has approximately four registered nurses that are case managers. These nurses' visit on a monthly basis to check the patient's vital signs, to update medications, and assure to

1	implement the plan of care. In addition, the nurses that stay with the patients provide the services				
2	on a case by case basis for each patient. The families provide the medications and supplies.				
3	Each patient's medical records and information is well maintained and accessible for staff				
4	There is also a binder kept at each patient's home that maintains a log of the day to day activity,				
5	updated medical list recommended by the physician and other notes.				
6	III. SUMMARY OF PCO OBSERVATIONS AT THE VARIOUS LOCATIONS				
7	The PCO continued to observe the Registered Nurses ("RNs") and some of the Licensed				
8	Vocational Nurse ("LVNs") at the patients' homes. Each RN visits about 14 patients per month.				
9	The family provides a plan of care stated by the doctors depending on the situation. The PCO				
10	found that the patients are well monitored, and the nurses had knowledge of the patients needs.				
11	The home was clean and had ample medical supplies for the patients needs. The patients visited				
12	needed all day home care and assistance to and from school. Some patients need all day homecare				
13	meaning there is an LVN between 8:00 a.m. and 5:00 p.m.				
14	The PCO specifically observed two patients where the LVNs have been with the patients				
15	for more than 2 years. The LVNs were positive and assisted the patients in administering the				
16	medications and providing daily therapy for the patients.				
17	IV. <u>RECOMMENDATIONS</u>				
18	There is nothing to recommend. The procedures and protocols of the registered nurses and				
19	LVNs are properly implemented.				
20	V. <u>CONCLUSION</u>				
21	The Patient Care Ombudsman (PCO) finds that all care provided to the patients by the				
22	Debtor is well within the standard of care.				
23	The PCO will continue to monitor and is available to respond to any concerns				
24	or questions of the Court or interested party.
