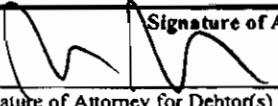

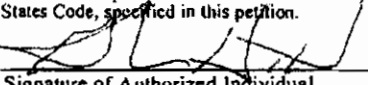

BANKRUPTCY FILING BY DOUGLAS FURNITURE OF CALIFORNIA, LLC

A special meeting of the Members of the Management Committee (the "Committee") of Douglas Furniture of California, LLC (the "Company") was held on July 9, 2008, at which the following resolutions were duly enacted by a vote of the Committee, and the same remain in full force and effect, without modification, unless and until the Committee adopts a further resolution to the contrary:

RESOLVED, that a Petition under the provisions of Chapter 11 of Title 11 of the United States Code shall be filed by the Company with the United States Bankruptcy Court, Central District of California;

FURTHER RESOLVED, that the law firm of Levene, Neale, Bender, Rankin & Brill L.L.P. ("LNBRB") has been and continues to be retained for purposes of filing the Chapter 11 bankruptcy case for the Company and representing the Company in its Chapter 11 bankruptcy case as bankruptcy counsel. The pre-bankruptcy retention agreement between the Company and LNBRB is hereby adopted, ratified and approved. Gordon Hitt ("Hitt") is hereby authorized and directed to execute an application for the Company to employ LNBRB as bankruptcy counsel to the Company in connection with the Company's Chapter 11 bankruptcy case;

FURTHER RESOLVED, that Hitt shall continue as the Company's chief

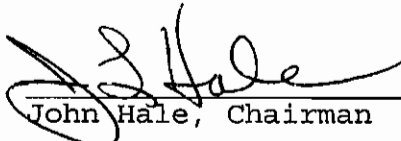
financial officer but, effective on July 4, 2008, Hitt's employment status with the Company shall be that of an independent consultant;

FURTHER RESOLVED, that as the chief financial officer of the Company, Hitt is hereby authorized and directed on behalf of and in the name of the Company to execute a Chapter 11 bankruptcy petition and all related documents and papers on behalf of the Company in order to enable the Company to commence its Chapter 11 bankruptcy case;

FURTHER RESOLVED, that as the chief financial officer of the Company, Hitt is hereby authorized and directed on behalf of and in the name of the Company to execute and file and to cause counsel to the Company to prepare with the assistance of the Company as appropriate all petitions, schedules, lists and other papers, documents and pleadings in connection with the Company's bankruptcy case, and to take any and all action which Hitt deems necessary and proper in connection with the Company's bankruptcy case without further approval of the Committee. Such actions shall include, but not be limited to, employing and compensating counsel and other professionals (both prior to and after the Company's bankruptcy filing); seeking Bankruptcy Court approval for the Company to use cash collateral and/or post-bankruptcy financing; compensating employees; purchasing materials; selling product; collecting accounts receivable; negotiating with creditors, lenders, vendors, suppliers and landlords; commencing litigation as deemed appropriate to assist the Company with respect to any of the foregoing; selling some, all or substantially all

of the Company's assets; and filing and attempting to confirm a plan of reorganization.

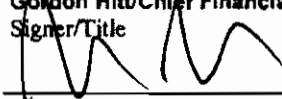
