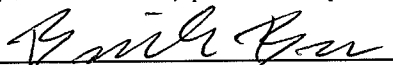

AUTHORIZING FILING OF VOLUNTARY PETITION IN BANKRUPTCY**

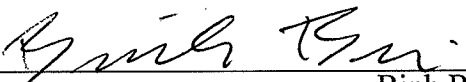

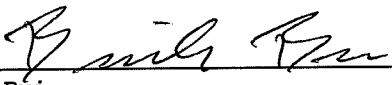
