GLOBAL NOTES PERTAINING TO DEBTOR'S SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENT OF FINANCIAL AFFAIRS

The Clare at Water Tower ("<u>The Clare</u>" or the "<u>Debtor</u>"), debtor and debtor in possession in the above-captioned case, respectfully represents as follows.

With the assistance of its professionals and advisors, the Debtor's management prepared the Schedules of Assets and Liabilities (the "Schedules") and the Statement of Financial Affairs (the "SOFA") pursuant to section 521 of title 11 of the United States Code (the "Bankruptcy Code") and Rule 1007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"). The Schedules and SOFA are unaudited and do not purport to represent financial statements prepared in accordance with Generally Accepted Accounting Principles in the United States ("GAAP"), and they are not intended to be fully reconciled to the financial statements.

The Debtor has used its best efforts to compile the information set forth in the Schedules and SOFA from its books and records maintained in the ordinary course of business. Although the Debtor's management has made every reasonable effort to ensure that the Schedules and SOFA are accurate and complete based on information that was available to them at the time of preparation, subsequent information or discovery may result in material changes to these Schedules and SOFA, including, but not limited to, the discovery of prepetition invoices that were not available (or that the Debtor had not yet received) at the time these Schedules and SOFA were prepared, and inadvertent errors or omissions may exist. The information provided herein, except as otherwise noted, is as of the date and time the Debtor commenced this chapter 11 case on November 14, 2011 (the "Petition Date"). Subsequent receipt of information or an audit may result in material changes in financial data requiring amendment of the Schedules and SOFA. Accordingly, the Schedules and SOFA remain subject to further review and verification by the Debtor. The Debtor reserves the right to amend the Schedules and SOFA from time-to-time as may be necessary or appropriate. These global notes regarding the Debtor's Schedules and SOFA (the "Global Notes") comprise an integral part of the Schedules and SOFA filed by the Debtor and should be referenced in connection with any review of the Schedules and SOFA. Nothing contained in the Schedules and SOFA shall constitute, or be deemed, a waiver of any rights, claims or defenses of the Debtor against any third party or with respect to this chapter 11 case or any related litigation or arbitration. Nothing contained in the Schedules and SOFA is intended or should be construed as an admission or stipulation of the validity of any claim against the Debtor, assertion made therein or herein or a waiver of the Debtor's rights to dispute any claim or assert any cause of action or defense against any party. The Debtor reserves all rights to dispute or challenge the characterization of the structure of any transaction or any document or instrument related to a creditor's claim.

- 1. <u>Information Subject to Confidentiality</u>. There may be instances in the Schedules and SOFA where the Debtor has deemed it necessary and appropriate to redact from the public record information such as names, addresses or amounts. Typically, the Debtor has used this approach because of an agreement between the Debtors and a third party, concerns of confidentiality or proprietary concerns, or concerns for the privacy of, or the confidentiality of personally identifiable information with respect to, an individual.
- 2. <u>Amendments</u>. The Debtor reserves the right to amend and/or supplement the Schedules and SOFA as necessary and/or appropriate.
- 3. <u>Estimates and Assumptions</u>. The preparation of the Schedules and SOFA required the Debtor to make estimates and assumptions with respect to the reported amounts of assets and liabilities, the amount of contingent assets and contingent liabilities on the date of the Schedules and SOFA and the reported amounts of revenues and expenses during the applicable reporting periods. Actual results could differ from those estimates.
- 4. <u>Asset and Liability Presentation</u>. Unless otherwise noted, each asset and liability of the Debtor is shown on the basis of the net book value of the asset or liability in the Debtor's accounting books and records as of the Petition Date, and not on the basis of current market values of such interest in property and/or liabilities. As applicable, assets that have been fully depreciated or were expensed for accounting purposes have no net book value. The Debtor reserves the right to amend or adjust the value of any asset or liability set forth herein.
- 5. <u>Setoffs</u>. The Debtor may incur certain setoffs and other similar rights from customers and suppliers in the ordinary course of business. Setoffs in the ordinary course can result from various items, including, but not limited to, pricing discrepancies and other disputes between the Debtor and its suppliers. These normal setoffs and other similar rights are consistent with the ordinary course of business in the Debtor's industry. Although such setoffs may have been accounted for when scheduling certain amounts, setoffs are not independently accounted for, and as such, are generally excluded from the Schedules and SOFA.

- 6. Prepetition Claims Paid Postpetition. As part of certain "first day" orders, the Debtor was authorized to pay, in its own discretion, certain outstanding prepetition claims, including, but not limited to, the payment of wages, expenses and benefits in accordance with that certain order dated as of November 16, 2011 [Docket No. 60] (the "Employee Wage Order"). Any such prepetition claims that have been or will be paid postpetition pursuant to authority granted by the Bankruptcy Court have been excluded from the Schedules and SOFA. The inadvertent inclusion of any such amounts shall not be deemed to obligate the Debtors to pay such amounts again. Further, the Debtor may continue to pay prepetition claims in accordance with the authority granted by the Bankruptcy Court.
- 7. Prepetition vs. Postpetition. The Debtor has sought to allocate liabilities between the prepetition and postpetition periods based on the information and research conducted in connection with the preparation of the Schedules and SOFA. As additional information becomes available and further research is conducted, the allocation of liabilities between prepetition and postpetition periods may change. Further, the Debtor reserves the right to change the allocation of liability to the extent additional information becomes available.
- 8. <u>Causes of Action</u>. Despite reasonable efforts, the Debtor might not have identified and/or set forth all causes of action against third parties in its Schedules and SOFA. The Debtor reserves any and all rights with respect to any causes of action it may have, and neither these Global Notes nor the Schedules and SOFA shall be deemed a waiver of any such causes of action nor may they be used in any litigation in this chapter 11 case.
- 9. <u>Claims Description</u>. Any failure to designate a claim on the Debtor's Schedules and/or SOFA as "disputed," "contingent" or "unliquidated" does not constitute an admission by the Debtor that such claim is not "disputed," "contingent" or "unliquidated." The Debtor reserves the right to dispute, or to assert offsets or defenses to, any claim reflected on its Schedules and SOFA as to amount, liability, priority, secured or unsecured status, or classification, or to otherwise designate any claim as "disputed," "contingent" or "unliquidated" by filing and serving an appropriate amendment. The Debtor reserves the right to amend its Schedules and/or SOFA as necessary and/or appropriate.
- 10. <u>Property and Equipment</u>. Owned property and equipment are listed at net book value. Nothing in the Schedules or SOFA (including, without limitation, the failure to list leased property or equipment as owned property or equipment or the listing of leased property or equipment as owned property or equipment or vice versa) is or shall be construed as an admission as to the determination of the legal

- status of any lease (including whether any lease is a true lease or financing arrangement), and the Debtor reserves all rights with respect to such issues.
- Insiders. In the circumstance where the Schedules and SOFA require information regarding insiders and/or officers and directors, the Debtor has attempted to include therein each of the Debtor's (a) "directors" (or persons in similar positions), and (b) employees that may be, or may have been during the relevant period, "officers," as such term is defined by applicable law. The listing of a party as an insider is not intended to be, nor should it be, construed as a legal characterization of such party as an insider and does not act as an admission of any fact, claim, right, or defense, and all such rights, claims, and defenses are hereby expressly reserved. Employees have been included in this disclosure for informational purposes only and should not be deemed to be "insiders" in terms of control of the Debtor, management responsibilities or functions, decision-making or corporate authority and/or as otherwise defined by applicable law, including, without limitation, the federal securities laws, or with respect to any theories of liability or for any other purpose.
- 12. Categories or Labels Used in Schedules and SOFA. Information requested by the Schedules and SOFA requires the Debtor to make judgments regarding the appropriate category in which information should be presented or how certain parties, claims or other data should be labeled. The Debtor's decisions regarding the category or label to use is based on the best information available as of the filing of the Schedules and SOFA and within the time constraints imposed by the Bankruptcy Code and Bankruptcy Rules. The Debtor reserves the right to modify, change or delete any information in the Schedules and SOFA by amendment, including to the extent some information currently presented should be moved to a different category or labeled in a different way.
- 13. <u>Schedule A</u>. The net book value of the building and land improvements located at 55 East Pearson Street, Chicago, IL 60611 is approximately \$47.5 million.
- 14. <u>Schedule B16</u>. In the ordinary course of business, prior to the Petition Date, the Debtor used centralized cash management systems (the "<u>Cash Management Systems</u>") to collect, transfer, and distribute funds generated by the Debtor's operations and to accurately record such collections, transfers, and disbursements as they were made. A description of the Cash Management Systems is set forth in the *Motion of Debtor for Order Authorizing (I) Maintenance of Existing Bank Accounts, (II) Continued Use of Existing Cash Management Systems, (III) Continued Use of Existing Business Forms, and (IV) Maintenance of Existing Investment Practices, filed on November 15, 2011 [Dkt. No. 10].*
- 15. <u>Schedule D—Creditors Holding Secured Claims</u>. Although the Debtor may have scheduled claims of various creditors as secured claims, the Debtor reserves all rights to dispute or challenge the secured nature or the validity of any such creditor's claim or the characterization of the structure of any such transaction or

any document or instrument related to such creditor's claim (including, but not limited to, whether any document is a true lease or financing arrangement). Without limiting the foregoing, the inclusion on Schedule D of creditors that have asserted liens of any nature is not intended to be an acknowledgement of the validity, extent, or priority of any such liens, and the Debtor reserves its right to challenge such liens and the underlying claims on any ground whatsoever. The descriptions provided in Schedule D are intended only to be a summary. Reference to the applicable agreements and other related relevant documents is necessary for a complete description of the collateral and the nature, extent, and priority of any liens. The Debtor does not have any co-debtors and no claim that may be set forth on Schedule D is intended to acknowledge claims of creditors that are otherwise satisfied or discharged by other entities. Nothing in the Global Notes or the Schedules and SOFA shall be deemed a modification or interpretation of the terms of such agreements.

Except as specifically stated herein, real property lessors, utility companies and other parties that may hold security deposits have not been listed on Schedule D. The Debtor has not included on Schedule D all parties that may believe their claims are secured through setoff rights, deposits posted by, or on behalf of, the Debtor, or inchoate statutory lien rights. Any such creditors may, however, be listed on Schedule F. Reasonable efforts have been made to determine the date upon which claims listed in Schedule D were incurred or arose. The Debtor does not list a date for each claim listed on Schedule D where such efforts would be unduly burdensome or cost prohibitive.

The amount set forth in Schedule D in respect of the secured claim of The Bank of New York Mellon Trust Company, N.A. as successor to J.P. Morgan Trust Company, N.A., as indenture trustee, does not reflect any reduction thereto by virtue of a potential setoff of such claim against all, or a portion of, certain trustee-held funds in the approximate amount of \$19.3 million.

16. Schedule E—Creditors Holding Unsecured Priority Claims. As part of certain "first day" orders, the Debtor was authorized to pay, in its own discretion, certain outstanding prepetition claims, including, but not limited to, wages, expenses and benefits under the Employee Wage Order and obligations to taxing authorities. Any such prepetition claims that have been or will be paid postpetition pursuant to the authority granted by the Bankruptcy Court have been excluded from the Schedules and SOFA. The inadvertent inclusion of any such amounts shall not be deemed to obligate the Debtor to pay such amounts again. Further, the Debtor may continue to pay prepetition claims in accordance with the authority granted by the Bankruptcy Court.

The listing of any claim on Schedule E does not constitute an admission by the Debtor that such claim is entitled to priority under section 507 of the Bankruptcy Code. The Debtor reserves the right to dispute the priority status of any claim on any basis. Reasonable efforts have been made to determine the date upon which

claims listed in Schedule E were incurred or arose. The Debtor does not list a date for each claim listed on Schedule E where such efforts would be unduly burdensome or cost prohibitive.

17. Schedule F—Creditors Holding Unsecured Nonpriority Claims. The liabilities identified in Schedule F are derived from the Debtor's books and records. The Debtor made a reasonable attempt to set forth its unsecured obligations, although the actual amount of claims against the Debtor may vary from those liabilities represented on Schedule F. The listed liabilities may not reflect the correct amount of any unsecured creditor's allowed claims or the correct amount of all unsecured claims. Parties in interest should not anticipate that recoveries in this case will reflect the relationship of aggregate asset values and aggregate liabilities set forth in the Schedules and SOFA. Parties in interest should consult their own professionals and/or advisors with respect to pursuing a claim. Although the Debtor and its professionals have generated financial information that the Debtor believes to be reasonable, actual liabilities (and assets) may deviate from the Schedules and SOFA due to certain events that occur throughout the duration of this chapter 11 case.

The claims listed on Schedule F arose or were incurred on various dates. In certain instances, the date on which a claim arose may be unknown or subject to dispute. Reasonable efforts have been made to determine the date upon which claims listed in Schedule F were incurred or arose. The Debtor does not list a date for each claim listed on Schedule F where such efforts would be unduly burdensome or cost prohibitive.

The notation "Seeking Executed Agreement" indicates that although the Debtor believes it entered into a Residency Agreement with such tenant, the Debtor is presently unable to locate such Residency Agreement. Accordingly, due to the absence of information, such Residency Agreements are listed as Schedule F liabilities but do not appear in Schedule G.

Certain claims are listed twice in Schedule F under the same Resident CWT# and Amount of Claim. Such duplicative claims represent cohabitants who each may have an interest in such claim.

18. <u>Schedule G—Executory Contracts</u>. While every effort has been made to ensure the accuracy of Schedule G, inadvertent errors or omissions may have occurred. Listing a contract, lease or agreement on Schedule G does not constitute an admission that such contract, lease or agreement is an executory contract or unexpired lease or that such contract, lease or agreement was in effect on the Petition Date or is valid or enforceable. The Debtor hereby reserves all of its rights to dispute the validity, effectiveness, status, or enforceability of any contracts, agreements, or leases set forth in Schedule G and to amend or supplement such Schedule as necessary. Certain of the leases and contracts listed on Schedule G may contain certain renewal options, guarantees of payment,

options to purchase, rights of first refusal, and other miscellaneous rights. Such rights, powers, duties, and obligations are not set forth separately on Schedule G; however, nothing in Schedule G shall operate as a bar to the Debtor's right to treat such agreements as severable. In addition, the Debtor may have entered into various other types of agreements in the ordinary course of its business, such as easements, right of way, subordination, non-disturbance agreements, supplemental agreements, amendments, letter agreements, title agreements, non-disclosure agreements and confidentiality agreements. Such documents may not be set forth on Schedule G.

The Debtor reserves all rights to dispute or challenge the characterization of the structure of any transaction or any document or instrument related to a creditor's claim, including, but not limited to, whether any lease is a true lease or financing arrangement.

The Debtor may be party to certain agreements that have expired by their terms, but all parties continue to operate under the agreement. Out of an abundance of caution, the Debtor has listed such agreements on Schedule G. The Debtor's inclusion of such contracts, leases or agreements on Schedule G is not an admission that such contract, lease or agreement is an executory contract or unexpired lease.

Omission of a contract, lease or agreement from Schedule G does not constitute an admission that such omitted contract, lease or agreement is <u>not</u> an executory contract or unexpired lease. The Debtor's rights under the Bankruptcy Code with respect to any such omitted contracts, leases or agreements are not impaired by the omission.

- 19. <u>Schedule H.</u> The Debtor does not have any co-obligors under its lease, contracts and/or other agreements. Any omission of a co-obligor on Schedule H or elsewhere in the Debtor's Schedules does not constitute an admission that such omitted co-obligor is <u>not</u> obligated or liable under the relevant debt. The Debtor's rights under the Bankruptcy Code and non-bankruptcy law with respect to any such omitted co-obligor are not impaired by the omission.
- 20. SOFA 1 & 2. The Debtor's fiscal year begins on July 1 and ends on June 30.
- 21. <u>SOFA 3b.</u> In the list of payments under SOFA 3b, the Debtor has not included payments for wages, compensation, or expenses made to employees, contract employees, or temporary employees in the ordinary course of business. The Debtor has paid employees, contract employees, and temporary employees pursuant to the Employee Wage Order for all prepetition wages, compensation, or expenses owed and thus believe they are not creditors. To the extent an employee, contract employee, or temporary employee is a creditor notwithstanding the Employee Wage Order, that employee, contract employee, or

- temporary employee may be entitled to priority treatment, but only in accordance with section 507 of the Bankruptcy Code.
- 22. <u>SOFA 4a.</u> Pursuant to the Employee Wage Order, the Debtor is authorized to honor all prepetition workers' compensation claims. Therefore, no workers' compensation actions have been listed on SOFA 4a.
- 23. <u>SOFA 21b.</u> There are no equity security holders as the Debtor is a not-for-profit entity. The sole member of the Debtor is Franciscan Sisters of Chicago Service Corporation.
- 24. <u>SOFA Exhibit 3bc</u>. The payment made to Michel Desjardins on November 11, 2011 in the amount of \$12,470.11 represents incentive compensation earned for the fiscal year ending on June 30, 2011.
- 25. Specific Notes. These Global Notes are in addition to the specific notes set forth in the individual Schedules and SOFA. The fact that the Debtor has prepared a "specific note" with respect to any of the Schedules and SOFA and not to others should not be interpreted as a decision by the Debtor to exclude the applicability of any Global Note to any of the Debtor's remaining Schedules and SOFA, as appropriate. Moreover, disclosure of information in one Schedule, SOFA, exhibit, or continuation sheet, even if incorrectly placed, shall be deemed to be disclosed in the correct Schedule, SOFA, exhibit, or continuation sheet.
- 26. <u>Totals</u>. All totals that are included in the Schedules represent totals of the liquidated amounts for the individual schedule for which they are listed. To the extent there are unliquidated, unknown or undetermined amounts, the actual total may be different than the listed total.
- 27. <u>Undetermined Amounts</u>. The description of an amount as "unknown," "TBD," or "undetermined" is not intended to reflect upon the materiality of such amount.
- 28. <u>Unliquidated Claim Amounts</u>. Claim amounts that could not be fairly quantified by the Debtor are scheduled as "unliquidated," "TBD," "undetermined" and/or "unknown."
- 29. <u>General Reservation of Rights</u>. The Debtor specifically reserves the right to amend, modify, supplement, correct, change, or alter any part of its Schedules and SOFA as and to the extent necessary and as it deems appropriate.
