SECOND INTERIM ORDER AUTHORIZING USE OF CASH COLLATERAL

UPON CONSIDERATION of the Motion of the Debtor and Debtor in Possession for entry of an order authorizing the use of cash collateral on an interim basis ("Motion") and setting a final hearing, and any additional papers filed in opposition thereto and in further support thereof; and having heard the arguments of counsel; and having considered any evidence presented; and due and proper notice of the Motion having been provided; and for good cause shown:

IT IS HEREBY ORDERED THAT:

- 1. The Motion is GRANTED as set forth herin;
- 2. That adequate protection of each secured creditor's interest in cash collateral proposed to be used by the Debtor in accordance with the Budget for the months of January and February 2019, which is attached hereto as Exhibit A, as follows:
 - a. The Debtor will provide secured creditors with a post-petition lien on all post-petition inventory and income derived from the operation of the business and assets, to the extent that the use of the cash results in a decrease in the value of secured creditor's interest in the collateral pursuant to 11 U.S.C. § 361(2). All replacement liens will hold the same relative priority to assets as did the prepetition liens;

b. The Debtor will only use cash collateral in accordance with the Budget attached

to this Motion as Exhibit A subject to a deviation on line item expenses not to

exceed 15% without the prior agreement of secured creditors or an order of the

Court;

c. The Budget shall be amended to include an adequate protection payment to

Strategic Funding on account of their secured claim in the amount of \$4,000 per

month and shall receive replacement liens in accordance with paragraph 2(a)

above.

d. The Debtor will keep all secured creditor collateral fully insured;

e. The Debtor will provide secured creditors with a complete accounting, on a

monthly basis, of all revenue, expenditures, and collections through the filing of

the Debtor's Monthly Operating Reports and provide the secured lenders with a

monthly variance report showing all actual uses on a line item bases and any

variance to the approved budget; and

f. The Debtor will maintain in good repair all of secured creditor's collateral;

3. The Debtor's use of cash collateral pursuant to this Order is authorized with a

complete reservation of rights of secured creditors to their various claims and lien

positions in and to the Debtor's assets.

4. A final hearing on the Debtor's Motion is set for 9:30 a.m. on March 1, 2019.
