# VERIFIED STATEMENT OF COUNSEL TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS PURSUANT TO FEDERAL RULE OF BANKRUPTCY PROCEDURE 2019

Pursuant to Rule 2019 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), the Official Committee of Unsecured Creditors (the "Committee") appointed in the chapter 11 cases (the "Chapter 11 Cases") of the above-captioned debtors and debtors-in-possession (collectively, the "Debtors"), by and through its proposed undersigned counsel, hereby submits this verified statement (the "Verified Statement") and, in support thereof, states:

1. On June 21, 2016 (the "Formation Date"), the Office of the United States Trustee appointed the Committee pursuant to section 1102(a)(1) of the Bankruptcy Code. *See* D.I. 132. On the same day, the Committee selected Lowenstein Sandler LLP and Goldstein & McClintock LLLP to serve as its co-counsel, and on June 24, 2016 selected BDO Consultants to serve as its financial advisor in the Chapter 11 Cases.
