**STIPULATION REGARDING APPOINTMENT OF MEDIATOR**

Pursuant to this Court's January 23, 2018, Scheduling Order (the "Scheduling Order"), Plaintiff, the Official Committee of Unsecured Creditors on behalf of the bankruptcy estate of HH Liquidation, LLC, *et al.* (the "Plaintiff"), and defendant Coyle Reproductions, Inc.
