**AMENDMENT TO DEBTOR'S AMENDED DISCLOSURE STATEMENT**  
**DATED AUGUST 12, 2016**

Debtor, Aziz Petroleum, Inc. amends Debtor's Amended Disclosure Statement, dated August 12, 2016 (the "Disclosure Statement") as follows:

1. A new section III. I. is added to the Disclosure Statement:

Other Potential Recoveries:

- (i) Debtor, through special counsel, Gene Reibman, Esquire, is still reviewing the potential claim for malpractice against Jesse Dean Kluger, Esquire and the amount of damages incurred. Special counsel was retained pursuant to Order dated May 3, 2015 (DE 94). This may result in a recovery for the estate of the Debtor.
- (ii) The real property taxes for the year 2014 and 2015 are to be paid by the current tenant, Krome Food Store #1, Inc. The tenant is expected to pay 2014 real property taxes by September 30, 2016. Further, debtor is also reviewing potential claims against the prior tenant, Krome Food Store #1, Inc., and its principal, Mohammed Dinaj Khan, for the failure to pay taxes for 2012 and proportionate share of 2013 real property taxes which were paid by the current tenant on behalf of the Debtor. This may also result in a recovery for the estate of the Debtor.
