DEBTOR'S EXPEDITED MOTION TO APPROVE USE OF CASH COLLATERAL

NEW_RIVER HOSPITALITY HOLDINGS, LLC, Debtor In Possession through undersigned counsel and in accordance with Bankruptcy Code Section 363 and Rule 4001 of the Federal Rules of Civil Procedure files this Motion to Approve Debtor's Use of Cash Collateral and states:

1. On January 27, 2017, (the "Petition Date") the Debtor filed a voluntary petition

under Chapter 11, Title 11 of the United States Code.

2. The Debtor is the owner and operator of a restaurant and Pizza delivery business.

3. In the ordinary course of its business, the Debtor's employees collect monies in

the form of cash in the form of cash, debit or credit card charges. This is the only source of

Debtor's revenue, Debtor uses this revenue to acquire food, pay rent, taxes, insurance and

payroll.

4. There are several UCC1s filed under the Debtor's name as follows:

Roger Scott Wilcox filed August 9, 2013 .Exhibit 1GFS Florida LLC dated June 17, 2014Exhibit 2American Express Bank FSB dated June 16, 2014Exhibit 3Corporation Service Company as Representative dated Dec 2014Exhibit 4Primecard, Inc dated March 11, 2015Exhibit 5Stonegate Bank dated May 26, 2016Exhibit 6

5. Only Corporation Service Company, As Representative has asserted an interest in "deposit accounts". Debtor believes Corporation Service Company to be its prior "merchant account" holder. Debtor is not delinquent with any of its current or prior merchant account holders. The merchant account holder retains the monies due for transaction fees, and deposits the balance of monies collected in the merchant account into the Debtor's bank account.

6. With the exception of Corporation Service Company, as Representative, all of the other entities as set forth in paragraph 4 assert an interest in personalty, equipment, accounts receivable and certain general intangibles such as "insurance proceeds". Debtor does not have any accounts receivable or insurance recoveries or other intangible collateral.

7. Roger Scott Wilcox was first party to file a UCC-1. He funded the Debtor's original build out and equipment purchases. Roger Wilcox is deceased, but his estate consents to the use of cash collateral.

8. This Motion is not an admission by the Debtor as to the nature, priority or extent of any parties interest in cash collateral and is simply filed to provide any party, which might believe they have an interest in cash collateral, with an opportunity to establish such an interest.

9. As the Debtor has recently filed this Chapter 11 bankruptcy case, a dialog with the above entities other than the estate of Roger Wilcox has not yet commenced. In fact, the Debtor is not even sure that some of the foregoing entities have claims against the estate of any kind.

10. Through this Motion the Debtor is seeking approval to continue to use cash collateral until such time as one of the foregoing entities can establish an interest in same.

WHEREFORE Debtor respectfully requests an order approving or authorizing the use of cash collateral and for such further relief as the court deems just.
