<sup>&</sup>lt;sup>1</sup> For the delivery of materials to holders in "Street" name, a project fee of \$10,000 plus \$2,000 for any cusip whose materials processed by reorganization departments in connection with the treatment election, or \$4,000 for the common stock, whose materials would be processed by proxy departments. This covers the coordination with all brokerage firms, banks, institutions and other interested parties, including the distribution of all solicitation election and voting materials. This assumes one distribution of materials, which will either be directed to the firms' proxy departments or reorganization departments, as appropriate. Certain pricing alternatives are described below, including in the event the bonds are not entitled to make a treatment election.

**Street name holders of bonds and stock**: \$7,500 plus \$500 per cusip to be noticed, with a cap of \$12,500;

**Registered holders**: \$0.50 - \$0.65 per holder (for two paper notices in the same envelope, subject to a \$500 minimum per class or issue).
