MOTION TO CONVERT CASE TO ONE UNDER CHAPTER 7; NOTICE OF OPPORTUNITY FOR HEARING; AND NOTICE OF HEARING

I. NOTICE OF OPPORTUNITY FOR HEARING

Your rights may be affected. You should read this document carefully and consult your attorney about your rights and the effect of this document. If you do not want the Court to grant the requested relief, or you wish to have your views considered, you must file a written response or objection to the requested relief with the Clerk of the United States Bankruptcy Court for the Western District of Oklahoma, 215 Dean A. McGee Avenue, Oklahoma City, OK 73102 no later than 14 days from the date of filing of this request for relief. You should also serve a file-stamped copy of your response or objection to the undersigned movant/movant's attorney [and others who are required to be served] and file a certificate of service with the Court. If no response or objection is timely filed, the Court may grant the requested relief without a hearing or further notice.

II. NOTICE OF HEARING

Please take notice that this motion has been set for hearing on February 20, 2013, at 9:30 a.m., before the Honorable Niles L. Jackson, in the 3rd Floor Courtroom, 215 Dean A. McGee, Oklahoma City, Oklahoma.

III. MOTION TO CONVERT

The United States Trustee ("UST"), in furtherance of the administrative responsibilities imposed pursuant to 28 U.S.C. § 586(a), respectfully requests this Court enter an order converting this case to one under chapter 7 pursuant to section 1112(b) of the United States Bankruptcy Code. In support of this motion the UST represents as follows:

1. The MA Cedar Lake Apartments, LLC ("Cedar Lake") case was commenced by the filing of a voluntary bankruptcy petition on October 28, 2010, seeking relief under chapter 11 of the United States Bankruptcy Code.

- 2. This case was originally assigned to the Honorable Sarah A. Hall. On August 23, 2012, Judge Hall ordered the Cedar Lake estate to be jointly administered with the estate of and under the case of Macco Properties, Inc., BK-10-16682-NLJ. *In re MA Cedar Lake Apartments*, *LLC*, BK-10-16563-SAH, "Corrected Order Directing Joint Administration of Chapter 11 Cases," docket #201. Upon entry of the order directing joint administration, the Cedar Lake case was reassigned to the Honorable Niles L. Jackson.
- 3. Contemporaneous with the filing of this motion, the UST has uploaded a proposed order terminating the joint administration of the estates of Macco and Cedar Lake.
- 4. Macco Properties, Inc. ("Macco") is an entity that held a 100% membership interest in MA Cedar Lake Apartments.
- 5. On October 23, 2012, this Court entered an order approving the proposed sale of Macco's membership interest in Cedar Lake to 250 West, LLC and Jennifer A. Price² ("Price.") *In re Macco Properties, Inc.*, docket ##1200 & 1246.
- 6. The respective parties to the sale executed the necessary documents to effectuate the transaction and the sale closed on November 28, 2012. That sale effectively accomplished a transfer of the ownership of Cedar Lake from Macco to Price and 250 West, LLC. Michael E. Deeba executed documents as the Chapter 11 Trustee of Macco; Price executed documents in her individual capacity; and Lew S. McGinnis executed documents in his capacity as manager of Cedar Lake and in his capacity as manager of 250 West, LLC.
- 7. The sale was conditioned upon Price and 250 West, LLC satisfying all outstanding creditor claims (both pre-petition and post-petition) at the closing of the sale. In anticipation of the closing, Price filed her first of two motions to dismiss the Cedar Lake case. *In re Macco Properties, Inc.*, docket #1284.

8. In discussing the sale contract, Price's first motion to dismiss, filed November 2, 2012, represented: "Under the contract, it is a condition of the Sale that, *inter alia*, All America Bank - the mortgagee on the Apartments - be paid in full at the Closing" and "the Movant shall have certified under penalty of perjury that the claims of the Remaining Creditors, as stated in Paragraph 7 hereof, have been satisfied in full." *Id.* at ¶¶ 6 & 10(b).

- 9. Price's first motion to dismiss was met with objections filed by the UST, debtor Cedar Lake, and All America Bank. *In re Macco Properties, Inc.*, docket ###1313,1314, and 1321, respectively. A central theme of the objections were based in part on Price's and McGinnis' prior performance³ and history of misconduct⁴, and the concern that Price and McGinnis would not pay or timely pay all creditor claims.
- 10. Price and McGinnis were unable to raise the necessary funds to close the Cedar Lake sale, and instead of having Price's first motion to dismiss denied, Price chose to withdraw her motion.
- 11. The sale eventually did close on November 28, 2012. Price renewed her efforts to obtain dismissal of Cedar Lake by filing her second motion to dismiss on November 30, 2012. *In re Macco Properties, Inc.*, docket #1326. However, in her second motion to dismiss, Price makes it clear that all creditors were not paid contemporaneous with closing. She now asserts that the pending bankruptcy is the cause for the "...unnecessary delay [in] payment of the remaining creditors' claims."
- 12. And now, after closing the Cedar Lake sale and after her second motion to dismiss, Price has objected to the claim of All America Bank. *In re Macco Properties, Inc.*, docket

The Macco Chapter 11 Trustee completed in January 2012 a similar sale of Division Properties, LLC ("Division Properties") to, in essence, the same parties. Division Properties consisted primarily of two apartment complexes in Oklahoma City, Oklahoma, the Remington Park Apartments and the Winslow Glen Apartments. Division Properties had been in Chapter 11 in the Western District of Oklahoma, Case No. 10-14203 and was dismissed on October 26, 2010. When the Chapter 11 Trustee turned over the properties to McGinnis and Price, it is believed that the trustee was current consistent with the agreement with the lender, the utilities were current, the property taxes were current, and the tenant security deposit accounts were fully funded. After assuming control, Price and McGinnis did not make the required mortgage payments. Price and McGinnis did not pay the utilities. Price and McGinnis plundered the security deposit accounts, again. On July 20, 2012, within seven months of Price and McGinnis' return to control of Division Properties, Price and McGinnis placed Division Properties into another Chapter 11 in the Northern District of Texas, Case No. 12-34679. Specifically, Division Properties' schedules reflect the current creditor makeup to be secured claims totaling \$7,426,398.67; priority claims (tenant security deposits) totaling \$45,016; and general unsecured creditors (primarily unpaid utility providers) claims totaling \$77,167.28. In that case, like so many others, Price and McGinnis made a multitude of promises and representations to pay off creditors in full, and have yet to do so.

#1329. Moreover, Price has failed to provide proof of the payment of the claims of the remaining creditors.

- 13. Price and McGinnis' failure to pay creditors, among other issues, has resulted in the UST, debtor Cedar Lake, and All America Bank objecting to Price's motion to dismiss. *In re Macco Properties, Inc.*, docket ###1358, 1356, and 1372, respectively.
- 14. As a result of the sale, Price and 250 West, LLC are now acting in their fiduciary capacity as a debtor-in-possession on behalf of Cedar Lake. Directors of a debtor under Chapter 11 are not fiduciaries of the corporation but, rather, they are fiduciaries of the estate, which the debtor in possession holds as trustee for the creditors. *Matter of Baldwin-United Corp.*, (S.D.Ohio 1984) 43 B.R. 443. And see *In re W.E. Tucker Oil, Inc.*, (Bkrtcy.W.D.Ark.1984) 42 B.R. 897. A debtor-in-possession is a fiduciary who represents the interests of the estate as well as its own. See also *In re Williams*, 152 B.R. 123 (Bkrtcy NDTX 1992) where the court reiterated that once a corporation becomes a chapter 11 debtor-in-possession, the management's fiduciary duty changes from a duty to the corporation's shareholders to a duty running to creditors as well as shareholders.
- 15. Section 1112(b) requires that the Court shall, in the absence of "unusual circumstances," convert a chapter 11 case to one under Chapter 7, or dismiss the case, if a party in interest establishes "cause." *In re TCR of Denver, LLC*, 338 B.R. 494, 498 (Bankr. Colo. 2006)("Congress has purposefully limited the role of this Court in deciding issues of conversion or dismissal, such that this Court has no choice, and no discretion, in that it 'shall' dismiss or convert a case under chapter 11 if the elements for 'cause' are shown under 11 U.S.C. § 1112(b)(4)").
- 16. Specifically, section 1112(b) provides:
 - (1) Except as provided in paragraph (2) and subsection (c), on request of a party in interest, and after notice and a hearing, the court shall convert a case under this chapter to a case under chapter 7 or dismiss a case under this chapter, whichever is in the best interests of creditors and the estate, for cause unless the court determines that the appointment under section 1104(a) of a trustee or an examiner is in the best interests of creditors and the estate.
 - (2) The court may not convert a case under this chapter to a case under chapter 7 or dismiss a case under this chapter if the court finds and specifically identifies unusual circumstances establishing that converting or dismissing the case is not in

the best interests of creditors and the estate, and the debtor or any other party in interest establishes that—

- (A) there is a reasonable likelihood that a plan will be confirmed within the timeframes established in sections 1121(e) and 1129(e) of this title, or if such sections do not apply, within a reasonable period of time; and
- (B) the grounds for converting or dismissing the case include an act or omission of the debtor other than under paragraph (4)(A)—
 - (i) for which there exists a reasonable justification for the act or omission; and
 - (ii) that will be cured within a reasonable period of time fixed by the court.
- 17. As alleged above, the debtor has failed to satisfy all outstanding creditor claims upon the closing of the sale between Macco and Price and 250 West, LLC.
- 18. Section 1112(b)(4) provides sixteen examples of "cause." The list is non-exhaustive and, thus, various non-identified acts or failure to act may also constitute cause.
- 19. Five of the listed causes are:
 - a) "substantial or continuing loss to or diminution of the estate and the absence of a reasonable likelihood of rehabilitation";
 - b) "failure to maintain appropriate insurance that poses a risk to the estate or to the public";
 - c) "unexcused failure to satisfy timely any filing or reporting requirement established by this title or by any rule applicable to a case under this chapter";
 - d) "failure to timely provide information . . . reasonably requested by the United States Trustee . . . " and
 - e) "failure to pay any fees or charges required under chapter 123 of title 28." U.S.C. § 1112(b)(4)(A), (C), (F), (H) & (K).
- 20. This case has been pending since October 2010. When Price sought this Court's approval of the sale of this debtor's estate to her, she represented that All America Bank and the remaining creditors would be "satisfied in full." Rather than abide by those terms Page 5 of 8

and her representations, the debtor has filed objections to claims. This case has been pending for over two years. Therefore the debtor and Price were certainly aware of any claims objections which would or could be asserted. Simply stated, for Price to represent that all estate claims will be paid at closing and then subsequently object to those claims is incongruous.

- 21. The actions of the debtor since the sale closing are indicative of an inability to reorganize. This is demonstrated by utilizing delay tactics, such as claim objections and delay of payment of creditors, to avoid the commitments previously promised to obtain a benefit (approval of the sale).
- 22. Subsequent to the November 28, 2012 sale closing, the debtor-in-possession's payment for insurance coverage was returned for insufficient funds. No proof of insurance has been provided. The creditors and the UST do not know whether the debtor has appropriate insurance coverage including, workers' compensation, liability and casualty coverage.
- 23. In addition, the UST believes that since the closing additional administrative claims approximating \$165,000 now exist and have gone unpaid.
- 24. Subsequent to the closing the debtor has not provided proof of the establishment of debtor-in-possession accounts to satisfy the requirement of section 345.
- 25. The debtor is delinquent in filing of the monthly operating report required under sections 704(a)(8) and 1106(a)(1) of the Bankruptcy Code. The last monthly operating report was filed by the chapter 11 trustee through November 28, 2012. *In re Macco Properties, Inc.*, docket #1408. The debtor has not filed any monthly operating reports since the last report filed by the trustee. Accordingly, there is no accountability to creditors, this Court or the UST.
- 26. This Court long ago recognized the importance of monthly operating reports: "The debtor-in-possession becomes its creditors' trustee and is required to conduct itself as one. The disclosure of the financial condition by periodic reporting is high on the list of fiduciary obligations and is to be excused only for justifiable cause." *In re Modern Office Supply, Inc.*, 28 B.R. 943, 945 (Bankr. W.D. Okla. 1983); accord In re Whetten, 473 B.R. 380, 383-84 (Bankr. Colo. 2012)(Failure to file monthly reports and financial disclosures calls into question the debtor's ability to reorganize).
- 27. The debtor has underpaid disbursement fees owed pursuant to 28 U.S.C. § 1930(a)(6). Page 6 of 8

The debtor is delinquent \$650 and is currently accruing additional fees for the first quarter of 2013.

- 28. In dismissing the debtor-in-possession's case for failure to file monthly reports and financial disclosures, the Court in *In re Whetten* observed: "Every debtor-in-possession faces the weighty duties of running a business and meeting the fiduciary obligations imposed by the Code." 473 B.R. at 383. Since the sale closing MA Cedar Lake Apartments, LLC, has ignored all of the duties set out in section 1107.⁵
- 29. Since the November 28, 2012, sale closing this debtor has not been represented by legal counsel. The debtor-in-possession, a limited liability company, is *pro se*. "The rule is well established that a corporation can appear in a court of record only by an attorney at law." *Flora Const. Co. v. Fireman's Fund Ins. Co.*, 307 F.2d 413, 414 (10th Cir. 1962) (citations omitted) *cert. denied* 371 U.S. 950, 83 S. Ct. 505, 9 L. Ed. 2d 499 (1963); 28 U.S.C. § 1654. Similar to a corporation, a limited liability company is a legal entity created by statute. Accordingly, the same rules apply pertaining to *pro se* representation. As held in *In re ICLNDS Notes Acquisition, LLC*, 259 B.R. 289, 294 (Bankr. N.D. Ohio 2001):

Logically, given that an LLC has some of the attributes of a corporation and some of a partnership, an LLC should be governed on this issue by the same rules that apply to those entities. Thus, whether an LLC is viewed as a corporation or a partnership or a hybrid, it may only appear in court through an attorney.

30. Simply put, a debtor, as debtor-in-possession, must timely discharge the unique responsibilities of Chapter 11 in order to enjoy its limited benefits. *In re Milford Connecticut Associates*, *L.P.*, 389 B.R. 303, 309 (Bankr. Conn. 2008). There are no "unusual circumstances" as contemplated in section 1112(b)(2) which justify the debtor's failures as set forth above.⁶

On September 7, 2011, this Court issued its opinion entitled "Order Denying Motion of Jennifer Price for Dismissal of Chapter 11 Case and Other Related Relief and Denying Plaintiff's Emergency Motion for Preliminary Injunction against Defendant, Michael E. Deeba, Trustee." *In re Macco Properties, Inc.*, docket #441. The current actions of this debtor, via Price, are consistent with the facts and circumstances set out in that order which concluded: "Rather, it is the Court's conclusion that Price and McGinnis should not be restored to management under any interpretation of the evidence." *Id.* at p. 51.

Once cause is established the burden shifts to the debtor to demonstrate unusual circumstances. *In re Whetten*, 473 B.R. at 384 ("The Code does not define 'unusual circumstances,' but the term contemplates

WHEREFORE, based on the foregoing, the UST respectfully requests that this Court enter an order granting this motion by converting this case to one under chapter 7; and for such other and further relief as the Court deems just, equitable and proper.
