WHEREAS, the Corporation has been constrained by low cash flow and an inability to raise additional equity or debt financing;

WHEREAS, the owners have explored possible strategic transaction which the Corporation could seek to either monetize its assets or generate increased revenue;

WHEREAS, the results of these strategic discussion produced no realizable outcomes and in the interim, due to decreasing revenue and cash reserves, the operations and affairs of the Corporation have effectively ceased;

WHEREAS, the Owners have determined that it is in the best interest of the Corporation to seek the protection of Chapter 11 of the United States Bankruptcy Code to reorganize its affairs.

NOW, THEREFORE, it is:
