

MASTER LEASE AGREEMENT

This MASTER LEASE AGREEMENT ("**Agreement**") made and entered into as of October 12, 2006 ("**Effective Date**"), between Mesaba Aviation, Inc., a Minnesota corporation, having its principal office at 1000 Blue Gentian Road, Suite 200, Eagan, MN 55121 ("**Lessor**") and Northwest Airlines, Inc., a Minnesota corporation, having its principal office at 2700 Lone Oak Parkway, Eagan, MN 55121 ("**Lessee**"), each a "Party" and collectively the "Parties."

1. ENTIRE AGREEMENT/ADDITIONAL TERMS

The terms, conditions and provisions of this Agreement, together with the schedules (the "**Schedules**") annexed hereto and by this reference made a part of this Agreement, constitute the entire Agreement between the Parties hereto and shall supercede all previous communications, representations, or agreements, either oral or written, between the Parties with respect to the subject matter of this Agreement. The Parties assume no responsibility beyond that specified herein or in the Master Sublease Agreement, dated as of October 12, 2006 between Northwest Airlines, Inc., as sublessor, and Mesaba Aviation, Inc., as sublessee (the "**Sublease**"), for any equipment or goods delivered unless this Agreement is signed by both Parties. In the event of a conflict between terms and conditions in the body of this Agreement and the Schedules, the body of this Agreement will govern.

2. EQUIPMENT TERMS

Lessor hereby agrees to lease to Lessee, and Lessee hereby agrees to lease from Lessor hereunder, each item of equipment ("**Equipment**") described in Schedule A attached hereto, as evidenced by the execution of this Agreement by Lessor and Lessee. Lessor and Lessee agree that that Lessee shall pay Basic Rent (as defined in Section 5 hereof) to Lessor with respect to the Equipment in the amount specified on Schedule A hereto in accordance with Section 5 hereof.

3. PURCHASE OPTION

In the event that (i) Lessor files a plan of reorganization in Lessor's pending proceedings ("**Lessor's Case**") under chapter 11 of title 11 of the United States Code (as amended from time to time, the "**Bankruptcy Code**") providing for the liquidation of all or substantially all of its assets (a "**Liquidating Chapter 11 Plan**") or publicly announces the intent to file a Liquidating Chapter 11 Plan, (ii) Lessor's Case is converted to a liquidation under chapter 7 of the Bankruptcy Code, (iii) Lessor commences a sale of, or enters into an agreement to sell, all or substantially all of its assets, which sale must expressly include the Equipment, (iv) Lessor discontinues or announces that it shall discontinue its current ground handling operations, provided that if Lessee or its affiliates or agents cause Lessor

to announce such discontinuance of ground handling operations solely as a result of Lessee or its affiliates or agents ceasing to use Lessor for ground handling operations on behalf of it or one of its regional air carrier affiliates it shall not constitute a Bankruptcy Event, or (v) in the event that Lessor discontinues flight operations but continues to perform ground handling operations, failure by Lessor to meet any of the ground handling performance standards specified in Schedule B hereto for a period of four consecutive days (such failure a "**Ground Handling Failure**") (any of (i), (ii), (iii), (iv) or (v), a "**Bankruptcy Event**"), Lessee shall have the option (the "**Purchase Option**"), to purchase all of the Equipment for an amount equal to the purchase price specified on Schedule A (the "**Purchase Price**"). Lessor hereby agrees to notify Lessee in writing no less than ten days prior to any discontinuance of ground handling operations as described in clause (iv) above, and the provision of such notice shall constitute a Bankruptcy Event under clause (iv) above. Lessee shall exercise such Purchase Option no later than the earlier of (i) 60 days following the occurrence of a Bankruptcy Event, or (ii) the date of termination of this Agreement under Section 4, by tendering payment of the Purchase Price to Lessor. Upon payment in full of the Purchase Price and payment of any costs of Lessor then due hereunder in connection with such purchase, Lessor shall transfer title to the Equipment to Lessee free and clear of all liens and mortgages of any nature whatsoever. Upon any such purchase, this Agreement shall automatically terminate. Notwithstanding anything to the contrary herein or in the Sublease, in the event that a Bankruptcy Event shall occur and Lessee exercises the Purchase Option by tendering payment as described above, but Lessor or any successor or assignee of Lessor's rights hereunder has not transferred title to the Equipment to Lessee or otherwise refuses to honor the Purchase Option, Lessee shall have the right to sublease the Equipment to a third party until Lessor (or such successor or assignee) shall have transferred title to the Equipment to Lessee pursuant to the terms hereof. In addition, in the event that Lessor is continuing flight operations and ground handling operations after the imposition of new employment terms on its union employees pursuant to Section 1113 of the Bankruptcy Code and/or the imposition of a wage reduction on its non-union employees, but a Ground Handling Failure has occurred, Lessee shall have the right to terminate the Sublease with respect to a portion of the Equipment and sublease such portion of the Equipment to a third party; provided that Lessee shall not have the right to terminate the Sublease and sublease to a third party such portion of the Equipment that is necessary to Lessor's then-current flight operations. Lessee and Lessor shall use good faith efforts at such time to determine what portion of the Equipment may be subleased to a third party and what portion shall remain subject to the Sublease.

Immediately upon receipt of the Purchase Price, Lessor will execute and deliver to the Lessee an "as is" quit claim bill of sale conveying Lessor's title to the Equipment free and clear of all liens and encumbrances, and a release of lien from Marathon Structured Finance Fund, L.P. ("**Marathon**"). Lessee agrees to take possession of the Equipment at its then location and in its then condition, without any warranty or representation by, or recourse against Lessor, other than

a representation and warranty that such Equipment is then free and clear of all liens and encumbrances. Lessee agrees that the existence of this Purchase Option does not render this Lease other than a true lease, nor does Lessee acquire any ownership interest in the Equipment until the Purchase Price is received by Lessor.

All Equipment sold pursuant to the Purchase Option by Lessor to Lessee shall be sold in an as-is, where-is condition, and all warranties, express or implied, including without limitation the implied warranties of merchantability or fitness for a particular purpose, as well as any obligation, liability, right, claim or remedy in contract or tort, whether or not arising from the negligence, actual or imputed, of Lessor, are hereby waived, except that Lessor does represent and warrant that, at the time of sale and delivery of the Equipment, title to the Equipment sold hereunder by Lessor to Lessee will be free and clear of any and all liens and other encumbrances. Lessee acknowledges that the property of Lessor, including this Agreement and the Equipment described herein, is currently subject to a security interest in favor of Lessor's Debtor-in-Possession financing lender, Marathon.

The remedies set forth herein are the sole and exclusive remedies of Lessee related to the Equipment, as aforesaid, for any claims, expenses, damage or economic loss arising out of the purchase of the Equipment. In no event shall the Lessor in any transaction described above be liable in tort or contract or under any other legal or equitable theory of law, for any incidental, special, indirect, or consequential damages.

4. EFFECTIVE DATE / TERMINATION

(a) Effective Date

The Agreement shall become effective on October 12, 2006, and shall remain in effect until April 1, 2007 (the "**Term**"), unless earlier terminated, in whole or in part, in accordance with the Agreement. The Parties acknowledge and agree that the Equipment, which is the subject of this Agreement, is also the subject of the Sublease, and shall be governed by the Sublease.

(b) Termination for Cause - LESSOR

If Lessee fails to perform its obligations under the Agreement and such failure to perform continues for a period of thirty (30) days after written notice of such failure, Lessor may terminate the Agreement, in whole or in part, upon written notice, and take such other action as may be permitted by this Agreement. If Lessor terminates under this provision, Lessee shall immediately return the Equipment in accordance with Sections 8(c) and 8(d).

In the event that Lessor elects to terminate the Agreement pursuant to this Section 4(b), then Lessee shall immediately pay Lessor an amount which is equal to (i) any unpaid amount due on or before Lessor terminated this Agreement, plus (ii) all attorney fees and court costs incurred by Lessor relating to the enforcement of its rights under the Agreement. Thereafter, Lessor may sell, lease or otherwise dispose of the Equipment at private or public sale, in bulk or separately with or without notice, without having the Equipment present at the place of sale; or Lessor may lease, otherwise dispose of, or keep idle all or part of the Equipment. The proceeds of sale, lease or other disposition, if any, of the Equipment shall be applied: (1) to all of Lessor's costs, charges and expenses incurred in repairing and selling, leasing or otherwise disposing of the Equipment including attorney fees; then (2) to the extent not previously paid by Lessee, to pay Lessor any unpaid amount due and owing prior to termination of Lease. Any surplus remaining may be retained by Lessor.

(c) Termination for Cause – LESSEE

If Lessor fails to perform its obligations under the Agreement and such failure to perform continues for a period of thirty (30) days after written notice to Lessor of such failure, Lessee may terminate this Agreement, in whole or in part, upon written notice, and take such other action as may be permitted by this Agreement.

If Lessee elects to terminate this Agreement under this Section 4(c) and does not elect to purchase the Equipment pursuant to Section 3, then: Lessee shall designate the location for Lessor to immediately take delivery of Equipment; Lessor shall be responsible for payment of any and all costs related to or arising out of the disposition of the Equipment hereunder; and any and all costs, charges and expenses incurred by Lessor in repairing, selling, leasing, or otherwise disposing of the Equipment following termination of this Agreement shall be the sole responsibility of Lessor.

(d) Termination for Convenience

If Lessor confirms a plan of reorganization in Lessor's Case (other than a Liquidating Chapter 11 Plan), either Party may terminate the Agreement with respect to all of the Equipment upon prior written notice to the other Party. If the Agreement terminates under this Section 4(d), Lessee shall subject to any election by the Sublessee pursuant to Section 4(e) of the Sublease, immediately return the Equipment to Lessor in accordance with Sections 8(c) and 8(d).

5. RENTAL

The rental amount payable to Lessor by Lessee for the Equipment (the "**Basic Rent**") will be the amount set forth in Schedule A with respect to the Equipment. Lessee shall pay Basic Rent with respect to the Equipment monthly in advance on the 1st calendar day of each month, or if such day is not a business day, on the next business day. The Parties agree that the Basic Rent payable by Lessee hereunder shall be net of any amounts owing to Lessee under the Sublease so long as the Sublease is in effect.

All payments of Basic Rent and any other amounts payable to Lessor hereunder shall be made directly by Lessee by wire transfer of immediately available funds prior to 10:30 a.m., Minneapolis time, on the due date thereof, to Lessor at the following account: LaSalle Bank, National Association, Chicago, Illinois, ABA No., 071000505, Account No. 5800434101, Account Name: Mesaba Aviation (or such other account as Lessor shall direct in a notice to Lessee at least 5 days prior to the date such payment is due).

6. [RESERVED]

7. TAXES

- (a) Lessee intends the rental payments hereunder to be net to Lessor, and Lessee shall pay all sales, use, excise, stamp, documentary and ad valorem taxes, license and registration fees, assessments, fines, penalties and similar charges imposed on the ownership, possession or use of the Equipment. During the term of this Agreement or any Schedule; Lessee shall pay all taxes (except Lessor's Federal or State net income taxes) imposed on Lessor or Lessee with respect to the rental payments hereunder, and shall reimburse Lessor upon demand for any taxes paid by or advanced by Lessor. Unless Lessee is otherwise directed by Lessor, in writing, Lessor shall file for and pay all personal property taxes assessed with respect to the Equipment during the term of this Agreement and Lessee shall, upon Lessor's demand, reimburse Lessor for the full amount of such taxes without regard to any discounts obtained by Lessor due to early payment or otherwise. Lessor may if it elects, estimate such personal property taxes and bill Lessee periodically in advance therefor.
- (b) No sales tax shall be collected by Lessor if: (i) a specific exemption applies to the Equipment leased hereunder, (ii) Lessee provides Lessor a validly executed resale exemption certificate, (iii) Lessee has been authorized to make tax payments directly to the applicable taxing authorities and so notifies Lessor in writing, or (iv) Lessor is obligated to pay the taxes as set forth herein. Lessor shall promptly, upon receipt from any tax authority of any levy, notice, assessment, or withholding of any tax

for which it may be obligated to pay on behalf of Lessee, notify Lessee in writing directed to the following address: Senior Tax Counsel, Northwest Airlines Inc., Dept. A4450, 2700 Lone Oak Parkway, Eagan, Minnesota 55121.

- (c) If under the applicable law of the taxing jurisdiction Lessee is allowed directly to contest such tax in its own name, then Lessee shall be entitled, at its own expense and in its own name, to contest the imposition, validity, applicability or amount of such tax and, to the extent permitted by law, withhold payment during pendency of such contest. If Lessee is not permitted by law to contest such tax in its own name, upon Lessee's request, Lessor shall in good faith and using best efforts, at Lessee's expense, contest the imposition, validity, applicability or amount of such tax. Lessor shall: (i) supply Lessee with such information and documents reasonably requested by Lessee as are necessary or advisable for Lessee to control or participate in any proceeding to the extent permitted herein, and (ii) make all reasonable efforts to assist Lessee with evidentiary and procedural development of any such proceeding or contest. Lessor shall in good faith and using best efforts, assist Lessee with the accumulation of information and documentation requested by Lessee to recover or seek a refund of any sales or use tax paid by Lessee as a result of its purchases pursuant to this Agreement.

8. INSTALLATION, USE AND RETURN OF EQUIPMENT

- (a) Upon delivery of the Equipment to Lessee, Lessee shall pay all transportation, installation, rigging, packing and insurance charges with respect to the Equipment.
- (b) Lessee shall, at all times during the Term of the Agreement, be entitled to unlimited use of the Equipment, and Lessee (or any sublessee) will comply with all laws, rules, regulations, and ordinances, and all applicable requirements of the manufacturer of the Equipment, which apply to the physical possession, use, operation, condition, and maintenance of the Equipment or otherwise. Lessee agrees to obtain (or to cause any sublessee to obtain) all permits and licenses necessary for the operation of the Equipment. Lessee (or any sublessee) shall not use or permit the use of the Equipment for any purpose for which the Equipment is not designed or intended.
- (c) Except upon purchase of the Equipment by Lessee pursuant to Section 3 hereof, Lessee, at its sole expense, shall, upon termination of the Agreement, deliver the Equipment to Lessor at the then current location of the Equipment or to such other location as Lessor shall reasonably request. In the event that the Sublease is no longer in effect, and this Agreement is terminated other than as a result of Lessee exercising the Purchase Option,

- (i) the Equipment shall be returned in the same operating order, repair, condition and appearance as of the Effective Date of the Agreement, reasonable wear and tear excepted; provided that the use of the Equipment by the sublessee pursuant to the terms of the Sublease shall not result in any breach of this Lease; and (ii) Lessee agrees to bear all costs associated with returning Equipment.
- (d) Upon the termination or expiration of this Agreement, excluding any termination in connection with a purchase of the Equipment by Lessee pursuant to Section 3 hereof, Lessee shall ensure that any necessary work or maintenance is performed on the Equipment so that the Equipment is returned to the condition or status it was in at the time of delivery, excluding reasonable wear and tear. The work or maintenance required by this Section shall consist of the following: obvious dents or scratches to the Equipment exterior shall be fixed, all Lessee decals, markers, and any other Lessee items shall be removed from the Equipment; and any holes or marks made onto or into Equipment shall be repaired. Lessor agrees that Lessee shall have the option to perform any of the maintenance or work described herein itself, or to pay a reasonably agreed upon amount to Lessor for the performance of the required work.
- (e) The Equipment shall not be removed from any location without Lessor's prior written consent.
- (f) Lessee shall be responsible for any fines or penalties arising from Lessee's use of the Equipment.
- (g) Upon return of the Equipment to Lessor, Lessee shall (i) return all manuals and maintenance records, to Lessor; and (ii) return and convey to Lessor at no cost to Lessor all upgrades and/or enhancements made to the Equipment that is inherent to the functioning of the Equipment.
- (h) So long as the Sublease is in effect, the Parties agree that compliance by the Sublessee with Sections 8, 9, 16 and 17 of the Sublease shall constitute compliance by Lessee with Sections 8, 9, 16 and 17 hereof.

9. MAINTENANCE AND REPAIRS

During the Term, Lessee shall be responsible for all maintenance and repairs with respect to each item of Equipment including all routine and preventative maintenance and repairs and all major maintenance and repairs, including but not limited to drive/power trains and tires. Lessee shall maintain the Equipment, or cause the Equipment to be maintained, in accordance with the manufactures' guidelines for preventive maintenance, retain copies of all maintenance contracts

and records relating to the Equipment and provide the same to Lessor upon request. All such maintenance shall be consistent with prudent industry practice and meet all legal and regulatory requirements. Lessee (or any sublessee) shall replace all worn, lost, stolen or destroyed parts of the Equipment with replacement parts at least meeting the standards required herein. Any and all parts incorporated into the Equipment as part of any maintenance required by this Section shall be deemed to be part of the "Equipment" on which such parts are incorporated and shall become the property of Lessor subject to this Agreement.

10. INSPECTION

At all reasonable times during the Term, Lessor or its representative may inspect the Equipment and the books and records of Lessee relating to the Equipment upon reasonable prior notice to Lessee, provided that any such inspection does not interfere with the normal operation of the Equipment or the business of Lessee (or any sublessee). Lessor shall not have any duty to make any such inspection nor shall it incur any liability by reason of not making such inspection.

11. OWNERSHIP

- (a) Lessee hereby acknowledges that the Equipment leased by it hereunder is the property of Lessor, and Lessor hereby acknowledges Lessee's leasehold interest in the Equipment. Lessee will keep Equipment free and clear of all claims, liens, and encumbrances solely attributable to Lessee arising as a result of any action of Lessee not contemplated by this Agreement or the Sublease. Lessor may, at Lessor's expense, provide labels to Lessee stating that the Equipment is owned by Lessor or stating that the Equipment is subject to a security interest in favor of Lessor's lender. Lessee will affix such labels to the Equipment pursuant to Lessor's reasonable instructions. Lessor reserves the right to substitute any Equipment for similar Equipment at any time.
- (b) Lessee shall execute and deliver such documents and other instruments requested by Lessor (at the cost and expense of Lessor) including Uniform Commercial Code financing statements to be filed to evidence the interest of Lessor and its assignee(s) in the Equipment or the Agreement.

12. WARRANTIES

- (a) Lessee agrees to look solely to the manufacturer of any Equipment parts or Equipment components, for any claim arising from any Equipment defect or breach of warranty.

- (b) Lessor hereby represents and warrants that it has good title to the Equipment, free and clear of all liens, mortgages, and security interests of any nature whatsoever other than the security interest existing in favor of Marathon, and Lessor has the right to lease such Equipment.
- (c) Upon Lessee's request, Lessor shall reasonably assist Lessee in processing claims and enforcing rights of Lessor arising under any existing Equipment parts or Equipment manufacturer's warranties, guarantees, or other similar undertakings for any Equipment leased hereunder; provided always that Lessee will indemnify Lessor for any reasonable costs and expenses incurred by Lessor in connection therewith including attorneys' fees, but excluding costs of Lessor's personnel.
- (d) Lessor covenants that Lessee shall quietly enjoy the Equipment under the terms of this Agreement, and any Agreement entered into pursuant hereto, without hindrance or disturbance by Lessor. Lessor acknowledges that Lessee has entered into this Agreement in reliance on this covenant of quiet enjoyment from Lessor. Lessor and Lessee further agree that each have complied, and will comply, with all applicable laws, regulations, standards, procedures and general requirements in its performance hereunder.
- (e) LESSOR, NOT BEING THE MANUFACTURER, NOR A SUPPLIER, NOR A DEALER IN THE EQUIPMENT, MAKES NO WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY, TO ANYONE, AS TO DESIGN, CONDITION, CAPACITY, PERFORMANCE OR ANY OTHER ASPECT OF THE EQUIPMENT OR ITS MATERIAL OR WORKMANSHIP. LESSOR ALSO DISCLAIMS ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR THE USE OR PURPOSE WHETHER ARISING BY OPERATION OF LAW OR OTHERWISE. LESSOR FURTHER DISCLAIMS ANY LIABILITY FOR LOSS, DAMAGE OR INJURY TO LESSEE OR THIRD PARTIES AS A RESULT OF ANY DEFECTS, LATENT OR OTHERWISE, IN THE EQUIPMENT WHETHER ARISING FROM THE APPLICATION OF THE LAWS OF STRICT LIABILITY OR OTHERWISE. AS TO LESSOR, LESSEE LEASES THE EQUIPMENT "AS IS". LESSOR SHALL HAVE NO OBLIGATION TO MAINTAIN, TEST, ADJUST OR SERVICE THE EQUIPMENT. REGARDLESS OF CAUSE, LESSEE AGREES NOT TO ASSERT ANY CLAIM WHATSOEVER AGAINST LESSOR FOR LOSS OF ANTICIPATORY PROFITS OR ANY OTHER INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES, NOR SHALL LESSOR BE RESPONSIBLE FOR ANY DAMAGES OR COSTS WHICH MAY BE ASSESSED AGAINST LESSEE IN ANY ACTION FOR INFRINGEMENT OF ANY UNITED STATES PATENT. LESSOR MAKES NO WARRANTY AS TO THE TREATMENT OF THIS

AGREEMENT FOR TAX OR ACCOUNTING PURPOSES. NO REPRESENTATIONS OR WARRANTIES OF THE EQUIPMENT PARTS OR EQUIPMENT COMPONENTS MANUFACTURER, OR ANY OTHER THIRD PARTY, CAN BIND LESSOR, AND LESSEE ACKNOWLEDGES AND AGREES THAT LESSOR SHALL HAVE NO OBLIGATIONS WITH RESPECT TO THE EQUIPMENT EXCEPT AS SPECIFICALLY SET FORTH HEREIN.

- (f) To the extent that the Lease or the Sublease may constitute collateral under Lessee's Super Priority Debtor in Possession and Exit Credit Guarantee Agreement, dated as of August 21, 2006 ("Lessee's DIP Facility"), Lessee hereby agrees to use commercially reasonable efforts to cause the lenders under Lessee's DIP Facility to acknowledge that neither the Lease nor the Sublease are part of any collateral available to such lenders thereunder.

13. ASSIGNMENT

This Agreement and the rights and obligations created hereunder shall not be assignable or delegable by either Party hereto without the prior written consent of the other Party; but, subject to the foregoing, this Agreement shall be binding upon and inure to the benefit of the Parties hereto, their respective successors, assigns, and legal representatives. Notwithstanding the foregoing, Lessor acknowledges Lessee's right to sublease the Equipment pursuant to the Sublease, and, upon the occurrence of a Bankruptcy Event or a Ground Handling Failure, Lessee may sublease the Equipment to a third party solely as provided in Section 3 hereof.

14. RESERVED

15. RELEASE AND INDEMNITY

Lessee shall indemnify Lessor against and hold Lessor harmless from, any and all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including reasonable attorney's fees arising out of, connected with, or resulting from Lessee's use or operation of the Equipment.

16. RISK OF LOSS

Lessee shall bear the entire risk of loss of any Equipment. In the event of actual or constructive total loss or destruction of any item of Equipment or damage thereto beyond economic repair during the term of the Agreement, or the loss of possession of any item of Equipment for more than thirty (30) days by reason of seizure, requisition, theft, disappearance, or otherwise (any such event, an "**Event of Loss**"), Lessee will immediately notify Lessor thereof. Within thirty (30) days

following the occurrence of an Event of Loss, Lessee (or any sublessee) will substitute equipment of a substantially similar make and model, having a value and utility at least equal to, and being in as good operating condition as, the Equipment that was the subject of such Event of Loss. Such replacement equipment shall be subjected to this Agreement (and to the Sublease, so long as it is in effect). For all purposes hereof, the property so substituted shall after such transfer be deemed part of the property leased hereunder and shall be deemed "Equipment" as defined herein. Upon such substitution, Lessee will transfer to Lessor all of Lessee's rights and interests to the Equipment which suffered such Event of Loss, and this Agreement shall be terminated with respect to such Equipment. No Event of Loss with respect to any Equipment which is being substituted pursuant to this Section 16 shall result in any reduction in Basic Rent.

17. INSURANCE

Lessee shall, at its expense, keep the Equipment fully insured against loss, fire, theft, damage or destruction from any cause whatever and such additional insurance against injury, loss or damage to persons or property arising out of the use or operation of the Equipment as is customarily maintained by the owners of like property. Lessee shall name Lessor as an additional insured with respect to any policies of insurance maintained by Lessee with respect to the Equipment.

18. REPRESENTATIONS AND WARRANTIES OF LESSEE

Lessee represents and warrants to Lessor and its Assignee(s) (i) that the execution, delivery and performance of this Agreement has been duly authorized, and constitute the legal, valid and binding obligation of Lessee, enforceable in accordance with its terms, and that no provision of this Agreement is inconsistent with Lessee's charter, by-laws, or any loan or credit agreement or other instrument to which Lessee is a party or by which Lessee or its property may be bound or affected, or conflict with any applicable law, rule or regulation, and no claim, action or suit is pending or has been threatened that would adversely affect Lessee's ability to enter into or perform its obligations under this Agreement.

19. [RESERVED]

20. WAIVER

Failure of either Party to insist upon strict performance of any of the terms and conditions herein shall not be deemed a waiver of any rights or remedies that the

Party shall have and shall not be deemed a waiver of any subsequent default of the terms and conditions hereof. Neither the continued use of Equipment by Lessee, nor the payment of rental fees under this Agreement shall be deemed or be a waiver of any right for any failure by Lessor to comply with any of the provisions of this Agreement.

21. LAW GOVERNING

The provisions of this Agreement shall be interpreted and construed in accordance with the laws of the State of Minnesota. Without limiting in any way the jurisdiction of the courts of any state, nation, or province, or Lessee's right to invoke the jurisdiction of such courts, Lessor hereby submits and consents to the jurisdiction of the courts of the United States of America and the State of Minnesota in any dispute arising out of this Agreement.

22. NOTICES

Unless otherwise stated in Agreement, all notices or requests given in connection with this Agreement will be given in writing and sent prepaid by certified mail return receipt requested, or overnight courier service to the person at the address listed below unless either Party notifies the other Party of a different address.

Any provision of the Agreement prohibited by or unlawful or unenforceable under any applicable law shall be ineffective as to such provision without invalidating the remaining provisions of the Agreement.

24. TIME OF THE ESSENCE

Lessor and Lessee acknowledge that time is of the essence in performance of their obligations under the terms of this Agreement.

25. RIGHT TO ASSURANCE

If either Party, in good faith, has reason to question the other Party's intent to perform, it may request that the other Party give written assurance of intent to perform. In the event that a request is made and no assurance is given within five (5) days, the requesting Party may treat this failure as an anticipatory repudiation of this Agreement.

26. NON-EXCLUSIVE & NOT REQUIREMENTS CONTRACTS

Notwithstanding anything to the contrary contained in this Agreement, Lessor acknowledges and agrees that (a) this is not a requirements contract and Lessee shall not be required to obtain its requirements for Equipment from Lessor and (b) Lessor is not the exclusive provider to Lessee of any Equipment and Lessee may at any time itself and/or through a third party obtain any Equipment (including parts or equipment to supplement or render unnecessary the Equipment).

27. BANKRUPTCY COURT APPROVAL

This Agreement is expressly subject to the approval of the United States Bankruptcy Court for the District of Minnesota ("**Lessor's Bankruptcy Court**") which is currently administering Lessor's Case under Chapter 11 of the Bankruptcy Code, filed in the United States Bankruptcy Court for the District of Minnesota on October 13, 2005 which case is being administered under Case No. 05-39258 ("**Lessor's Case**"). Lessor agrees that it will diligently seek the approval of this Agreement from the Bankruptcy Court. Upon receipt of Bankruptcy Court approval, this Agreement shall be effective as of the Effective Date first written above. If this Agreement is not approved by the Bankruptcy Court, this Agreement will not be in effect, and Lessor shall have no liability to Lessee and Lessee shall have no liability to Lessor.

28. SECTION HEADINGS

Section headings are for convenience only and shall not be construed as part of the Agreement.

29. WAIVER OF SET-OFF

Except as specified in Section 5 hereof, in connection with exercising the Purchase Option, Lessee hereby waives any right of set-off, counterclaim, recoupment, defense or other right which Lessee may have against Lessor, as Lessor or as

Sublessee under the Sublease, for any reason whatsoever (whether in connection with the transactions contemplated hereby or any other transactions). If for any reason this Lease is terminated, in whole or in part, and the Sublease is terminated to the same extent, Lessee hereby waives any claims for damages except as expressly provided herein and therein.

30. EFFECT OF TERMINATION

Upon termination of this Agreement in accordance with the provisions hereof, the Term shall end and each provision of this Agreement shall no longer be applicable (provided that such termination will not relieve any Party of any obligation for any breach of this Agreement prior to termination). Notwithstanding the foregoing, Sections 7 Taxes, 8 Installation, Use and Return of the Equipment, 12 Warranties, 15 Release and Indemnity, 17 Insurance, 21 Law Governing, 22 Notices, and 30 Effect of Termination shall survive the termination of this Agreement and remain in full force and effect in accordance with their terms.

In addition, the Parties agree that upon any termination of this Agreement in accordance with the provisions hereof, the Sublease shall be automatically terminated to the same extent as the termination of this Agreement.

31. COUNTERPARTS

This Agreement may be executed and delivered by facsimile/electronic transmission and in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

32. CHANGES/ADDITIONS/AMENDMENTS

This Agreement may not be amended, modified or supplemented except by a written instrument duly executed by the parties hereto. Any changes or additions to this Agreement or any Schedule or Exhibit to this Agreement must be documented by the Parties in writing, and signed by authorized representatives of both Parties.

33. CONFLICTS

Any conflict between the Articles and Sections within this Agreement, its Schedules, or any Amendments shall be construed and resolved in the following order of precedence:

- (a) Amendments/Addenda to this Agreement
- (b) This Agreement
- (c) Schedules, Exhibits or Attachments to this Agreement

SCHEDULE B

GROUND HANDLING PERFORMANCE STANDARDS

Performance Standard
CRJ Handling by Mesaba

Basis of measurement: With respect to Mesaba's handling of CRJs operated by Pinnacle, the performance standard below will be measured on a 4-day rolling period basis.

Station Delay (D/O)

Goal: 78% or higher
Formula: Departures within zero minutes of scheduled departure

Flights will not be delayed more than twenty-two percent (22%) of the time due to the Mesaba (the "handling company"). Flight departure delays attributed to handling company will only include the following areas for which the handling company has responsibility: loading errors (LDS) and passenger accommodation errors (PAS). All other delays such as ATC, maintenance, etc. will not be charged against the handling company.

For purposes of this performance standard, LDS and PAS are defined as follows:

LDS (Loading)

A delay incurred from loading/unloading excessive amounts of unusually large or heavy cargo, searching for the load due off at the station, checking load to ensure accurate gross weight, or waiting for transfer mail or cargo connections. Includes failing to load planes by CLC (central load control), late entry of cargo data for weight and balance purposes or failing to follow Company or Station policy that results in a Station delay. Also includes a delay due to a late NOTOC (Notice to Captain). Additionally, includes situations where the pilot questioned the DG (dangerous goods) paperwork and/or load and either the paperwork or load was changed. Does NOT include on-line transfer luggage.

PAS (Passenger Accommodation)

Delay caused due to a passenger-related problem or situation that delayed procedures preventing an on-time departure or the volume of passengers being checked in or otherwise processed prevents an on-time departure. Includes passenger becomes ill onboard. Does not include late seating of passengers or oversale situations.
