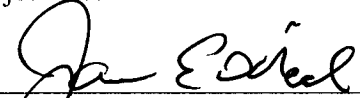

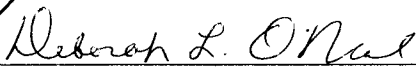
Directors James E. O'Neal and Deborah L. O'Neal voted in favor of the resolutions and Director Gary Brown abstained from voting.
