proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having found that the relief requested in the Motion is in the best interests of the Debtors' estates, their creditors, and other parties in interest; and the Court having found that the Debtors have provided appropriate notice of the Motion and the opportunity for a hearing on the Motion under the circumstances; and the Court having reviewed the Motion; and the Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before the Court; and there being no opposition to the Motion; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

- 1. The Motion is granted as set forth herein.
- 2. The time within which the Debtors must assume or reject the Operating Leases is extended through and including April 29, 2012, and the consents attached as **Exhibit 2** to this Order satisfy the written consent required by section 365(d)(4) of the Bankruptcy Code.
- 3. Nothing in the Motion or this Order shall be deemed or construed as (a) an assumption or rejection of any agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code or (b) an admission with respect to whether any of the Debtors' contracts or leases is an unexpired lease of nonresidential real property within the meaning of section 365(d) of the Bankruptcy Code.
- 4. This Order is without prejudice to the right of the Debtors to request an additional extension of time to assume or reject the Operating Leases.
- 5. All time periods set forth in this Order shall be calculated in accordance with Bankruptcy Rule 9006(a).
