**Attachment to Exhibit D of Bankruptcy Petition**

As a result of the financially-devastating circumstances faced recently by certain Chrysler automotive dealers, the principal obligor – on a \$1,315,000 promissory note that I personally guaranteed – defaulted. The principal obligor is the owner of a Chrysler franchise that was recently terminated by Chrysler L.L.C. In connection with the Guaranty that I signed, I pledged to the obligee the assets in three brokerage accounts, which constitute almost all of my life savings. On the afternoon of May 20, 2009, I learned that the obligee had levied on approximately \$550,000 in one of my brokerage accounts. At literally any time within the next 24-48 hours, that creditor will be seizing all of the remaining funds in my other two brokerage accounts, totaling approximately \$750,000. Accordingly, it is imperative that I file this petition for chapter 11 relief immediately in order to reorganize my affairs at this extremely difficult and stressful time.
