
I am currently a federal inmate, having been housed in New Jersey at FCI Fort Dix since November of 2011. My company, Farmville Group LLC, has also been domiciled here in New Jersey since I was placed here in 2011. Accordingly, I am filing Chapter 11 here under this petition, which will assist me to postpone a foreclosure sale on a property owned by my company.

In light of my status as an inmate,I am asking that a copy of the filed petition be promptly mailed back to me the day it is received and stamped so that I can take that filing number and mail a copy of the stamped petition to the appropriate parties to stop the foreclosure. Also, I will have a money order mailed to the court to pay the first installment towards the petition fee, as noted on the application to pay in installments. If the fee can be waived due to my status as an inmate ,please indicate that when you send me the copy of the filed petition. A member of my family on the outside will send the payment in on the date indicated on my application, with the money order made payable to the U.S Bankruptcy Court.

Once filed I will send in the required filings and I am in the process of seeking an attorney to take the case over once the initial filing is made, as I am aware that as a Chapter 11 it will require an attorney to represent the company at some early stage after the filing is made.

Please be sure to mail me a copy of the stamped and filed petition with the filing number the same day it is filed , so that I can be timely in my action to stop the sale. Thank you in advance for your assistance.
