At the hearing the Court considered the pleadings and papers, the arguments of counsel, the withdrawal of objections by Darlene Ore and Jamie Parker based on certain conditions set forth below, and the satisfaction of the limited objection filed by the Nevada Department of Taxation based on the conditions set forth below.

The Court also considered the Ballot Summary [DE 169], which showed 100% acceptance for Classes 1 and 4 of the Plan, as well as the Declaration of Kim Moser-Clark [DE 170], which demonstrated the feasibility of the Plan.

After considering all of the above, the Court entered its Findings of Fact and Conclusions of Law on the record at the hearing in accordance with Federal Rule of Civil Procedure 52(a), as incorporated pursuant to Federal Rule of Bankruptcy Procedure 9014(c). Good cause appearing,

IT IS HEREBY ORDERED as follows:

- The Debtor's Second Amended Disclosure Statement is APPROVED. 1.
- The Debtor's Second Amended Plan is CONFIRMED, subject to the following 2. amendments:
- The personal liability of Chris Parker under all obligations to his ex-wife A. Jamie Parker pursuant to their divorce decree and related documents shall not be altered in any way by confirmation of the Plan.
- B. All post-petition taxes owed to the Nevada Department of Taxation shall be current as of the Effective Date (January 1, 2018).
- C. In the event all taxes to the Nevada Department of Taxation are not paid within the statutory 5-year deadline set forth in 11 U.S.C. §1129(9)(c)(ii), such taxes shall not be discharged, nor shall any statutory liability of responsible individuals be terminated, and the Debtor shall continue making the payments set forth in the Plan until such debt is paid in full with interest as specified in the Plan.
- Chris Parker shall not receive a monthly salary until after the monthly D. payments under the Plan are made.
