Upon the application, dated March 1, 2018, (the "Application"), of the Debtor and Debtor in possession, WILLIDPEWS BBQ EMPORIUM, INC. for an order pursuant to Section 363 of Title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (as amended, the "Bankruptcy Code"), authorizing use of cash collateral of CACHE VALLEY BANK ("Secured Creditor"); this Court having jurisdiction to consider the Application and the relief requested, this matter being a core proceeding pursuant to 28 U.S.C. § 157(b); the venue being proper pursuant to 28 U.S.C. §§ 1408

1 and 1409; having determined legal and factual bases establishing just cause exists; it is hereby

2 **ORDERED** that the Motion is GRANTED; it is further

3 **ORDERED** that Debtor is hereby authorized to use cash collateral on an interim basis
4 pursuant Fed. R. Bankr. P. 4001(b) and LR 4001(b) for a period up to and including the date of
5 entry of a final order relating to cash collateral, in accordance with the budget attached to this Order
6 as Exhibit A; it is further

7 **ORDERED** that Debtor shall provide adequate protection to Secured Creditor in amount
8 of \$1,690.00 per month, commencing on March 15, 2018, and continuing on the fifteenth (15th) day
9 of each month thereafter until further order of this Court, confirmation of a Chapter 11 plan of
10 reorganization or dismissal of this case.
