JEFFREY AVO UVEZIAN, being duly sworn, deposes and says:

1. I am the President of the International Tobacco Partners, Ltd. (the “Debtor”), the above-named petitioner.
2. The Debtor is a corporation maintaining offices located at 1010 Northern Boulevard, Suite 240, Great Neck, N.Y. (the “Premises”), which it leases from a third party for approximately \$4,900.00 per month. I am advised by the Debtor’s counsel that the Debtor is not a “small business”, as that term is defined in the Bankruptcy Code.

3. The Debtor is an importer of cigarettes and cigars which it sells to distributors across this county. Its annual sales for 2010 are estimated to approximate between eight and ten million dollars.

4. The Debtor currently employs three full-time employees, one independent contractor, and one officer. The Debtor has personal property assets with an approximate value of \$970,000.00 comprised of, among other things, cash in the sum of \$500,000.00 accounts receivable in the sum of \$40,000.00, inventory in the sum of \$400,000.00 and furniture and office equipment in the sum of \$27,000.00. The Debtor's liabilities total approximately \$4,275,000.00, of which \$20,000.00 represents priority claims, \$15,000.00 represents secured creditors' claims and \$4,240,000.00 represents unsecured creditors' claims.

5. At this time, no property of the Debtor is in the possession or custody and control of any public officer, receiver, trustee or assignee for the benefit of creditors, mortgages, pledges or assignees. There is one (1) action currently pending against the Debtor in the United States District Court, Eastern District of New York, Central Islip Division, which bears Index Number CV 09-3797(ADS) with the following party as plaintiff: Citiland Limited. Upon information and belief, this action has not yet resulted in a judgment against the Debtor.

6. A list of the creditors holding the twenty (20) largest unsecured claims against the Debtor's estate, together with their addresses and the amount due, is annexed to the Debtor's petition. The schedule of secured creditors, also annexed hereto, reflects that the Debtor has only one secured creditor holding a claim in the approximate amount of \$15,000.00, which has a lien on furniture and office equipment.

7. The Debtor's payroll including taxes for its three full time and one independent contractor for the thirty (30) day period following the filing of the petition herein is approximately \$16,000.00. Jeffrey Avo Uvezian, the Debtor's only officer, will receive approximately \$10,500.00, which includes related payroll taxes.

8. In addition, the Debtor estimates that its general administrative expenses, for the thirty (30) day period following the commencement of this proceeding, will be approximately \$581,500.00. These expenses include, but are not limited to, rent, utilities, escrow payments, insurance, payroll and purchases. A copy of the Debtor's projected income and expenditures for the first thirty (30) days of its proceeding, is annexed hereto.

9. The Debtor's filing is necessitated by its inability to pay its debts as they are coming due. Its lack of cash flow was mainly caused by one customer who owed approximately \$400,000.00 to the Debtor but didn't pay its bill. Additionally, the Debtor's sales volume decreased from 2008 to 2009 by some \$2,000,000.00. This decrease was due to the general market conditions, increased compliance costs and increased taxes on its products.

10. The Debtor believes that with the protection of this Court, it will be able to marshal and preserve its assets, restructure its business arrangements and debts, and propose a meaningful and acceptable plan of reorganization to its creditors.

**WHEREFORE**, your Deponent prays that the Debtor be continued in the operation and management of its business and affairs pending further order of this Court.
