



**DEBTOR'S AFFIRMATION PURSUANT TO
LOCAL BANKRUPTCY RULE 1007-2**

YEHUDA NELKENBAUM affirms as follows:

1. I am the President and sole shareholder of New York Spot Inc. (the "Debtor"), which owns a building located at 442 West 22nd Street, New York, New York (the "Property").
2. I submit this Affirmation in accordance with Local Bankruptcy Rule 1007-2 in support of the voluntary petition filed by the Debtor under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code").
3. The Property consists of a 4 story building with 23 Class B apartments, most of which are occupied.
4. Although subject to a pending foreclosure, the Debtor believes that the Property retains significant equity and elected to seek Chapter 11 relief to preserve its going-concern value.
5. More particularly, Intervest National Bank ("Intervest") originally commenced a foreclosure action in Supreme Court of the State of New

York, New York County last year under Index No. 650877/2010. Recently, Intervest assigned its mortgage to a third-party investor, West 22nd LLC, which has or will be substituted as the plaintiff in the foreclosure action.

6. Since August 13, 2010, the Property has been under the control of a Receiver. An order of reference appointing Michael Roberts, Esq. of 401 Broadway, New York, N.Y. 10013 as a referee to compute was entered on April 13, 2011.

7. Under the protections of Chapter 11, the Debtor hopes to refinance or sell the Property to preserve the equity over and above the existing mortgage debt. Upon information and belief, the holder of the first mortgage is owed a principal balance of approx. \$1,920,000 (subject to adjustment) while the Property has a value of approximately \$3,000,000.

8. Pursuant to Bankruptcy Rule 1007(d), a list containing the names and addresses of the known creditors holding the twenty (20) largest unsecured claims against the Debtor is attached to this petition.

9. Also, in accordance with Local Bankruptcy Rules, a list containing the name and address of the Debtor's secured creditors and equity holders is attached to this petition.

10. I do not receive a salary and have not received any distributions from the Debtor in my capacity as sole shareholder.

11. Because the Property is in the possession of a receiver, I do not

have access to current information and reserve the right to supplement the petition once the Debtor is returned to possession of the Property.
