- I. I am the President and sole shareholder of Shaker Gardens Inc. (the "Debtor"), which owns a 176 unit garden apartment complex located at 76 Shaker Heights Drive, Monticello, New York (the "Property").
- 2. I submit this Affirmation in accordance with Local Bankruptcy Rule 1007-4 in support of the voluntary petition filed by the Debtor under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code").
- 3. The Property is substantially occupied and has been in the possession of a receiver, Douglas Rosenberg of BPC Management Corp., 80 Livingston Street, Brooklyn, NY 11201, for more than a year's time.
- 4. Although subject to a pending foreclosure and an imminent foreclosure sale, the Debtor believes that the Property retains potential equity if sold on a

going-concern basis and elected to seek Chapter 11 relief to prevent foreclosure of the Property under a distressed sale.

- 5. Carver Federal Savings Bank ("Carver") previously commenced a foreclosure action in Supreme Court of the State of New York, Sullivan County in 2009 under Index No. 004113/2009. A referee, Peter R. Eriksen, Esq. of Jacobowitz & Gubits, LLP, 158 Orange Avenue, Walden, NY 12586, has been appointed. On December 8, 2010, Carver obtained a judgment of foreclosure and a sale had been scheduled for June 14, 2011.
- 6. Upon information and belief, the holder of the first mortgage is owed a principal balance of approximately \$6,006,070.30. The Property has a value of approximately \$7,800,000 based on the latest available appraisal performed by the Leitner Group, Inc. in December of 2006. Despite the passage of time, I believe that the Property has kept its value given the steady cash flow.
- 7. I do not receive a salary and have not received any distributions from the Debtor in my capacity as sole shareholder.
- 8. Because the Property is in the possession of a receiver, I do not have access to current information and reserve the right to supplement the petition once this information becomes available.
