Tim Ziss, declares the following under penalties of perjury pursuant to 28 U.S.C. § 1746:

- 1. I am the manager of 325 N Broadway LLC, which is the sole shareholder of Oxford Fine Properties Inc. (the "Debtor"). I am also the president of the Debtor and submit this Declaration in accordance with Local Bankruptcy Rules in support of the Debtor's filing of a voluntary petition under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code").
- 2. The purpose of this Declaration is to provide background information regarding the Debtor's business, the circumstances prompting the Chapter 11 filing, the Debtor's assets and capital structure, and the Debtor's strategies for reorganization.

#### (A) The Debtor's Business

3. The Debtor is a New York Corporation, with current offices at 9322 Third Avenue, Brooklyn, NY. The Debtor is the holder of a 49 year net lease (the "Lease") expiring in 205353 for commercial property located at 213-07 Northern Boulevard, Bayside, New York (the "Property"). The Property consists of approximately 20,000 square feet of retail and office

space, plus approximately 18,000 square feet of garage parking. The Property contains eight units and is currently occupied by seven commercial subtenants, with one small vacancy. Current annual base rents are approximately \$637,000 per year.

- 4. The Debtor acquired the Lease to the land in 2004, and thereafter constructed the current commercial building situated thereon. The project was delayed and proved more costly than anticipated but it is now complete.
- 5. The Debtor's interest in the Property is subject to a leasehold mortgage, currently held by Huskies Trust 2013-1 ("Huskies"), in the principal amount of approximately \$3.3 million.

#### (B) Events Leading Up to Bankruptcy

- 6. The leasehold mortgage previously fell into arrears. A foreclosure action was commenced in 2012 by the prior holder of the mortgage, First American International Bank ("FAIB"). During the foreclosure action, the Debtor and FAIB entered into a forbearance agreement whereby the Debtor was provided a period of one year to cure various arrears and reinstate the mortgage debt.
- 7. The forbearance agreement expired in February 2014, at which time the Debtor was prepared to pay the arrears in order to reinstate the mortgage. During the forbearance period, FIAB assigned the mortgage to Huskies, which insisted that the forbearance only provided a one year window to refinance the mortgage and not reinstate the original terms.
- 8. Given the impasse, the parties resumed the foreclosure litigation in the State Court. Rather than litigating over the terms of the forbearance agreement, the Debtor believes it is far more efficient to utilize the provisions of the Bankruptcy Code to either cure and reinstate the mortgage under 11 U.S.C. § 1124, or restructure the mortgage based on amount equal to the

current fairmarket value, with post-confirmation interest to be established in accordance with <u>Till</u>

v. SCS Credit Corp., 541 U.S. 465 (2004).

(C) Assets and Capital Structure

9. Pursuant to Bankruptcy Rule 1007(d), a list containing the names and addresses of

the creditors holding the twenty (20) largest unsecured claims against the Debtor is attached to

this Petition as Exhibit "1".

10. The Debtor's secured creditors are listed in the accompanying bankruptcy

schedules and consist primarily of the Huskies' Mortgage claim.

11. The Debtor estimates that the Property has a current value of approximately \$2.8 -

\$3.0 million.

(D) Reorganization Strategy

12. The Debtor intends to proceed promptly with the filing of a plan of reorganization

that either provides for a cure and reinstatement of the leasehold mortgage or an alternate

treatment of the mortgage debt consistent with Section 506(a). I recently acquired the stock of

the Debtor with a view of spearheading the reorganization effort.
