George Armstrong, being duly sworn, deposes and says under penalty of perjury as follows:

1. I am the Managing Member of HANCOCK STREET SML LLC ('Debtor') and I am submitting this affidavit pursuant to Local Rule 1007-4 in support of Debtor's Chapter 11 filing.

2. On October 29, 2014, the Debtor filed a Petition under Chapter 11 of Title 11 of the United States Code, 11 U.S.C. § 101 et. seq. ('the Bankruptcy Code').

3. The Debtor is in the business of purchasing properties with incomplete construction projects thereon, retaining subcontractors to complete said construction projects, and the subsequent sale of those properties. It is anticipated that the Debtor's profits are to be derived from the sale of these properties.

4. The Debtor owns the following parcels of real estate (collectively referred to as the 'Properties') in connection with its business:

- (i) 725 Macon St, Brooklyn, NY;
- (ii) 53 Rochester Ave, Brooklyn, NY;

- (iii) 438 Quincy St, Brooklyn, NY;
- (iv) 562A Lafayette Ave, Brooklyn, NY;
- (v) 224 Spencer St, Brooklyn, NY; and
- (vi) 792 Dekalb Ave, Brooklyn, NY.

5. The construction projects at the Properties are financed by a first and second mortgage held by THE COMMUNITY PRESERVATION CORP. and a third mortgage held by the CITY OF NEW YORK acting by and through its DEPARTMENT OF HOUSING PRESERVATION AND DEVELOPMENT.

6. The completion of the construction projects at the Properties are delayed, as additional funding is required.

7. During the ongoing delay, An action was brought by THE COMMUNITY PRESERVATION CORP. against the Debtor on or about July 18, 2013 in the Supreme Court of the State of New York, County of Kings to foreclose on its first and second mortgages recorded against the Properties captioned *THE COMMUNITY PRESERVATION CORP. v. 
