## DECLARATION PURSUANT TO LOCAL BANKRUPTCY RULES

Clement Saad declares the following under penalties of perjury pursuant to 28 U.S.C. § 1746:

- 1. l am the Managing Member of Kramerica Enterprises, LLC (the "Debtor").
- I submit this Declaration in accordance with Local Bankruptcy Rule 1007 in support of the Debtor's filing of a voluntary petition ("Petition") under Chapter 11 of Title
   of the United States Code (the "Bankruptcy Code").

## (A) Material Events Leading up to the Bankruptcy

- The Debtor is seeking Chapter 11 relief in an effort to resolve an ongoing dispute with its secured lender, Bank of America
- 4. The Debtor's primary asset is a small airplane, previously used for corporate purposes. The Debtor originally obtained a mortgage from Bank of America on or about January 23, 2007 in the principal sum of \$529,647 (the "Loan"). The proceeds of the Loan were used to purchase the airplane, and Loan is secured by a lien against the airplane.
- 5. The Loan historically performed well and the Debtor remained current with all monthly payments until recently, when the Debtor fell behind in its monthly obligation

of \$3,964.51, consisting of principal of \$1,755.17 and interest of \$2,209.34. The current arrears amount to approximately \$12,470.98.

- 6. The Debtor tried to bring itself current, but the cure payment was rejected, and Bank of America has initiated steps to repossess the airplane.
- 7. The Debtor is filing the instant Chapter 11 so as to exercise is right to cure and reinstate the Loan pursuant to Section 1124 of the Bankruptcy Code. In light of the small amount involved and the relatively straightforward issues of law, the Debtor intends move expeditiously to file a plan of reorganization to cure the limited three month default and reinstate the Loan.
- 8. The petition is being filed in the Eastern District of New York, Brooklyn Division, as related to the successful Chapter 11 case of an affiliate, Ray Realty Fulton, Inc., case number 09-41225-DEM, which confirmed its plan of reorganization by Order dated June 2, 2010, and was closed on October 28, 2010.

## (B) Assets and Capital Structure

- 9. The Debtor has only one secured creditor, Bank of America.
- 10. The Debtor's assets consist primarily of the airplane and a small checking account.
- 11. The Debtor's two equity holders are David Sievers and the undersigned, who each hold a 50% membership interest in the Debtor.
- 12. There is no property of the Debtor in the possession or custody of any third party, including a receiver or public officer.
  - 13. All of the Debtor's books and records are maintained by Mr. Sievers.

14. The Debtor has no employees and does not pay any salary.
