DECLARATION OF CHARLES IZZO, Jr.

Charles Izzo, being duly sworn, deposes and says:

1. I am the managing member of Sunset Vista Mobile Village, LLC, a New York Limited Liability Company (the "Debtor"), and I submit this declaration pursuant to Federal Bankruptcy Rule 1007
2. The Debtor is in the business of owning and managing real property consisting of a Trailer Park in Cossackie, New York.
3. Due to an apparent miscommunication with the servicer of the Debtor's mortgagee, mortgage payments made by the Debtor appear to be misapplied. As a result, a foreclosure proceeding was commenced. Only after a default judgment was entered and the bank had a receiver appointed, *ex parte*, did the Debtor become fully aware of the actions taken by the bank.

4. The Debtor believes that its arrearages are relatively small. The Debtor attempted discuss the matter with bank representatives and to reconcile its books with the bank's records. The Debtor vigorously attempted to amiably resolve the issues, but all attempts were fruitless leading to this Chapter 11 filing.

5. The Debtor has lined up sufficient funds to immediately proffer a plan which reinstates the mortgage.

6. Accordingly, the Debtor believes it is in the best interests of all of its creditors that it be afforded a reasonable opportunity to utilize the Chapter 11 process to pursue all reorganization options.

7. This case was not originally commenced under Chapter 7 or 13 of the Bankruptcy Code.

8. No committee was organized prior to the filing of this case.

9. A schedule of the Debtor's 20 largest unsecured creditors is annexed hereto as Exhibit A.

10. The names and addresses of the five largest secured creditors are annexed hereto as Exhibit B.

11. A summary of the Debtor's assets and liabilities is annexed as Exhibit C.

12. The Debtor does not have any publicly held shares of stock, debentures or other securities.

13. Pre-petition, the Debtor is in the possession or custody of a receiver.

14. The Debtor has its principal office at 3 Shale Lane, Cambell Hall, New York 10916.

15. The Debtor's substantial assets are located at 11559 State Route 9W, Coxsackie, New York .

16. There are no known proceedings pending against the Debtor, except its mortgagee's foreclosure proceeding pending in the Supreme Court - Greene County. Case No. 12-0696

17. The Debtor's senior management is comprised of Charles Izzo, as managing member.

18. The estimated payroll to employees (exclusive of officers, directors, stockholders and partners) for the thirty (30) day period following the filing of the chapter 11 petition is \$0.00.

19. The estimated amount to be paid for services to its officer, director and shareholders for the thirty (30) day period following the filing of the Chapter 11 petition is \$0.00.

20. The estimated schedule of cash receipts and disbursements for the thirty (30) day period following the filing of the Chapter 11 petition, net cash gain or loss, obligations and receivables of the Property is annexed as Exhibit D.

Conclusion

21. In addition to the foregoing, a copy of the corporate resolution authorizing the filing of the instant Chapter 11 petition is annexed as Exhibit E.

22. The Debtor believes it is in the best interests of all of its creditors that it be afforded an opportunity to reorganize its obligations in Chapter 11.

23. The needs and interests of the Debtor and its creditors will best be served by the Debtor's possession of its assets and management of its affairs as a Debtor-in-Possession under Chapter 11 until confirmation of a reorganization plan.
