15. The Debtor estimates a weekly payroll to non-insider employees of approximately \$550 for the thirty days following the commencement of the case. The Debtor does not intend to make distributions to officers, directors or stockholders for the thirty days following the commencement of this case. No financial consultant has been retained.

16. The Debtor does not anticipate any change in business receipts and expenses during the thirty day period following the commencement of this case. A balance sheet and profit and loss statement is attached.


