- 2. The Debtor operates food distribution business offering quality meats and cheeses from a cooperative unit located in the Hunts Point Cooperative Market, the largest wholesale food distribution and meat processing center in the world.
 - 3. No pre-petition committee was organized prior to the Order for relief.
 - 4. The Debtor's two secured creditors are **Signature Bank and NMHG**
 - 5. The Debtor's inventory consists of meats, cheeses, and other such items.

Financial.

- 6. The names and addresses of the twenty largest unsecured creditors, excluding insiders, appears on Schedule "A" to this affidavit.
- 7. To the best of my knowledge, the only suits or proceedings in which the Debtor is named as a party are: (1) a Petition to Confirm Arbitration Award filed by UFCW Local 342 union entitled: "RICHARD ABONDOLO, as Chairman of the Board of Trustees of UFCW LOCAL 342 HEALTH CARE FUND; RICHARD ABONDOLO as Chairman of the Board of Trustees of UFCW LOCAL 342 ANNUITY CARE FUND; RICHARD ABONDOLO as Chairman of the Board of Trustees of UFCW LOCAL 342 SAFETY, EDUCATION and CULTURAL FUND; RICHARD ABONDOLO as Chairman of the Board of Trustees of UFCW LOCAL 342 v.
