



**AFFIDAVIT OF ROBERT DEMARCO IN  
SUPPORT OF DEBTOR'S FIRST DAY MOTIONS**

Robert DeMarco, being duly sworn according to law, upon his oath, deposes and say: I am the Chief Financial Officer of DeWitt Rehabilitation and Nursing Center, Inc. (the "Debtor" or "DeWitt"). I have served as the Chief Financial Officer of DeWitt since March 2010 and had previously served in that position from 1994 through 2005. As such, I am familiar with the Debtor's day-to-day operations, business affairs and records, and am authorized to make this Affidavit on the Debtor's behalf.

**I. INTRODUCTION**

1. On or about January 24, 2011 (the "Petition Date") DeWitt filed a voluntary petition for relief pursuant to Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code"). Since the Petition Date, the Debtor has remained in possession of its assets and has continued in the management of its business as a Debtor-in-Possession pursuant to Sections 1107 and 1008 of the Bankruptcy Code.

2. No trustee, examiner or committee of creditors has been appointed in this case.

3. To avoid the potentially disruptive impact that the commencement this Chapter 11 case may have on the Debtor's operations, to protect the interests of the residents of DeWitt, the community at large and other parties-in-interest, and to facilitate the orderly transition into Chapter 11, the Debtor has requested that the Court consider, on an expedited basis a motion for an Order authorizing the Debtor to satisfy, and directing HSBC Bank USA (the "Bank") to honor, pre-petition gross salaries and related obligations to the Debtor's employees (the "First Day Motion").

4. The purpose of the First Day Motion includes, among other things: (a) protection of the residents of DeWitt and the public during the initial stages of the Debtor's Chapter 11 case by ensuring the Debtor's ability to provide vital care and medical services; (b) maintaining and bolstering employee morale in order to reduce employee attrition; (c) enabling the Debtor to continue operating as it pursues a successful Chapter 11 reorganization; and (d) preserving the value of the Debtor's estate. The First Day Motion is crucial to the Debtor's ability to remain open and to provide high-quality care to the residents of DeWitt as the Debtor works to reorganize in a manner that best protects the health and interests of the public as well as the interest of the Debtor's creditors.

5. The purpose of this affidavit is to: (i) explain the circumstances precipitating the Debtor's Chapter 11 proceeding; (ii) provide general information about the Debtor and its business operations that are germane to the First Day Motion; (ii) provide information required by Local Rule 1007-2. The factual statements in this affidavit are based on my personal knowledge, information supplied to me by others under my supervision, my review

of relevant documents and/or my opinions based on my experience and knowledge of the Debtor's operations, financial condition and the healthcare industry in general.

## **II. THE DEBTOR'S BUSINESS AND BACKGROUND**

### **A. The Debtor's Business**

6. DeWitt owns and operates a 499-bed skilled residential nursing and rehabilitation center (the "Nursing Home") located at 211 East 79th Street, New York, New York.<sup>1</sup>

7. The Nursing Home is a private for profit facility. The Nursing Home provides a wide range of services including: (a) 24-hour skilled nursing, (b) on-site staff physician, (c) physical, occupational and speech therapy, (d) challenging admissions including infectious diseases and Alzheimer patients, (e) dental services, (f) personalized nutrition, (g) beauty and barber salon, and (h) 24-hour security.

8. The Debtor is a significant employer in New York City, employing approximately 497 people in various health-care, foodservice, security, maintenance, administrative, and professional/management positions.

9. DeWitt is a sub-chapter S corporation organized and existing under the laws of the State of New York. Marilyn Lichtman is the sole shareholder of DeWitt and has been the Operator since it opened in or about 1967. Ms. Lichtman oversees the entire operation of DeWitt.

10. Joseph D. Cornetta is DeWitt's Administrator and Chief Operations Officer and he assumed that position on September 30, 2010 for the purpose of assisting in the reorganization of the day to day operations of DeWitt. Mr. Cornetta has served as administrator

in several health care facilities over the past 27 years and has been retained to assist receivers for other nursing homes and is expertly qualified to assist in the reorganization of DeWitt.

11. DeWitt has a reputation and will continue to maintain that reputation as a provider of high quality care to its residents as that has been the mission of DeWitt since it opened in 1967 and a recent survey conducted by the New York State Department of Health in October 2010 confirms the high standard of DeWitt's care despite its financial difficulties. There has been no change in the quality of care that has been provided to its residents and no change in the quality of care will be tolerated.

**B. Factors Leading to Bankruptcy Filing**

12. The Debtor's Chapter 11 bankruptcy filing was precipitated by, among other things, the failure to control costs over the last several years which ultimately resulted in unpaid obligations to the Internal Revenue Service, New York State and Local 1199 Employee Benefit Funds. The Debtor struggled in 2010 to work out arrangements with those creditors while restructuring its operations. Unfortunately, DeWitt was advised in December 2010 that New York State will not be instituting a higher compensation rate in the near future, which required the Chapter 11 filing to assist the restructuring without endangering patient care. DeWitt already instituted several changes since the summer of 2010 and those changes are continuing, which include modification of the methodology for the operation of the pharmaceutical department and the utilization of its nursing staff from nursing agencies, and other day to day operational changes.

13. The changes that were implemented and are continuing to be implemented will not be reflected in the cash flow of DeWitt for the next 90 days but thereafter the changes



will be significant as Joe Cornetta and I take the necessary steps to put DeWitt back where it was before I left in 2005.

14. The Debtor is in the process of implementing a comprehensive restructuring plan in order to: (i) reduce core operating costs; and (ii) and continue to improve the efficient management of DeWitt that will ultimately result in higher revenue and lower management and day to day costs.

**C. The Debtor's "Long-Term" Financial Obligations**

15. The Debtor has one primary long term obligation, a \$10,000,000.00 term loan granted by Metropolitan National Bank and Israel Discount Bank that was incurred in 2004 (the "Loan"). The Loan is secured by a first security interest, which encumbers all of DeWitt's assets, including accounts receivable and cash in the bank accounts and is also secured by a first mortgage on the real property owned by 210 East 80th Street LLC ("Landlord"). Marilyn Lichtman is the owner of the Landlord and she granted the mortgage on October 28, 2004. The payments to Metropolitan National Bank and Israel Discount Bank are current through December 31, 2010.

16. DeWitt is working with its lender to restructure the Loan and to provide additional cash flow relief.

**D. Value of the Debtor's Assets**

17. DeWitt's accounts receivable is approximately ten million (\$10,000,000.00) dollars and that is the primary asset of DeWitt, separate and apart from the overall value of all of the equipment and day to day operations of DeWitt. The Debtor's total liabilities as of the Petition Date is approximately thirty million (\$30,000,000.00) dollars.

**E. Budget**

18. Attached hereto as **Exhibit "A"** is a true and accurate copy of the Debtor's projected budget for February 2011. As reflected in the budget, the Debtor anticipates that its cash position will remain stable over the next 5 weeks.

**II. FIRST DAY MOTIONS**

**A. Motion for Order (I) Authorizing Payment of Pre-Petition Wages, Employee Benefits and Expense Reimbursement, (II) Authorizing and Directing HSBC Bank USA to Release Prepetition Restraining Notice and Honor Checks with Respect to Wages and Employee Benefits, and (III) Approving Payment of Postpetition Wages and Benefits**

19. To avoid the significant risks of resignations and of discontent or loss of morale among essential employees, and in view of the priority awarded to wage claims, it is necessary and appropriate that the First Day Motion be granted. The Debtor requires the continued service of its employees in order to : (i) ensure the continuity and quality of the medical care provided to the residents of DeWitt; (ii) to ensure that the business operations will not be threatened; and (iii) so that the Debtor may continue, without unnecessary interruption, its efforts to achieve a successful reorganization.

20. The Debtor currently has approximately 497 employees who have historically been paid on a weekly basis. The aggregate weekly amount of wages paid to employees is approximately \$420,000.00.

21. The payroll for the pay period from January 16, 2011 through January 22, 2011 is due on January 28, 2011. The wages and benefits earned by the employees during their pay period constitute prepetition wages and benefits. Therefore, it is imperative that the Debtor obtain authorization to pay priority prepetition wage claims to the employees on or before January 28, 2011.

22. The Debtor employs approximately 497 employees, none are entitled to weekly gross payroll of over \$10,000.

23. In addition to payment of pre-petition wages as set forth above, the Debtor seeks to pay the wages for all employees in the ordinary course when those obligations come due. Moreover, in the ordinary course of its business, the Debtor provides benefits to its employees (collectively, the "Employee Benefits"). The Employee Benefits include, but are not limited to, health insurance, COBRA coverage vacation pay, sick pay, holiday pay, workers' compensation, disability, and related programs. The estimated monthly cost to the Debtor of offering the Employee Benefits is approximately \$460,000.00.

24. The payroll and Employee Benefits for the employees for the above-mentioned periods is less than \$10,000 for each employee.

25. Further, the Debtor seeks authority, in its sole discretion, to issue new postpetition checks, or to effect new fund transfer requests, with respect to the employee wages and Employee Benefits, in order to replace any prepetition checks or fund transfer requests that may be dishonored and denied.

26. Finally, the Debtor is also seeking authority to reimburse employees for expenses incurred in the ordinary course of business. It is respectfully submitted that any employee reimbursement should not count against an employee's individual cap on wages and benefits of \$10,000. The Debtor further submits that the total amount of reimbursement by the Debtor for all employee expenses in the ordinary course of business shall not exceed an aggregate amount of \$5,000.00 on a monthly basis.

27. The obligations to its employees for which the Debtor seeks authorization to honor were earned by individuals employed by the Debtor, and are for services rendered

within one hundred and eighty (180) days before the commencement of the Debtor's case. The obligations are for wages, including vacation and sick leave pay, and payroll taxes based on such wages, and for the other Employee Benefits mentioned above.

28. The relief requested pursuant to the First Day Motion will not prejudice creditors, but rather will protect their interests.

WHEREFORE, it is respectfully requested that this honorable Court grant the Debtor's request as set forth in the motions filed simultaneously with the Bankruptcy Petition and such other and further relief as this Court deems just and proper.
