

**JOINT AFFIDAVIT PURSUANT TO

TERENCE TRAYNOR affirms as follows:

1. I am a managing member of both 41 Murray Street LLC (“41 Murray”) and Amarach LLC (“Amarach”) (collectively, the “Debtors”) which are seeking Chapter 11 relief contemporaneously herewith as related cases. I respectfully submit this Joint Affidavit in accordance with the Local Bankruptcy Rule 1007-2 in support of the Debtor’s filing of their respective voluntary petitions (“Petitions”) under Chapter 11 of the Title 11 of the United States Code (the “Bankruptcy Code”).

2. 41 Murray owns a commercial condominium located at 41 Murray Street, New York, New York (the “Property”), consisting of approximately 5,800 square feet, including the ground floor, basement and sub-basement.

3. The Property is currently occupied by a third-party tenant, Brendyl, Inc. ("Brendyl"). Brendyl conducts a restaurant business at the Property under the name Eamonn's Irish Pub & Restaurant ("Restaurant"), pursuant to a commercial lease dated December 1, 2009 (the "Lease").

4. For the last several months, Brendyl has failed to pay rent to the Debtors and is utilizing Amarach's liquor license improperly. Brendyl's delinquencies have caused the Debtors to go into default with its own lenders and these Chapter 11 cases are being filed to stabilize the situation while immediate action is pursued against Brendyl.

5. I believe that the Property retains equity even though it is subject to pending foreclosure proceedings commenced by New York Business Development Corporation ("NYBDC") in Supreme Court of the State of New York, New York County. NYBDC holds a consolidated first mortgage in the total principal sum of approximately \$1,988,917.99 originally held by NYBDC and Empire State Certified Development Corporation ("ESCDC").

6. 41 Murray is also obligated to World Trade Center Small Business Recovery Fund, Inc. ("Small Business Recovery Fund") under a working capital loan of \$150,000.

7. As noted above, the Debtors' financial issues relate directly to the fact that Brendyl is no longer paying rent and has refused to vacate the Property. Exacerbating the situation, Brendyl is improperly utilizing Amarach's State Liquor Authority License and even extended that license in August 2011 without Amarach's consent.

8. Under the protections of Chapter 11, the Debtors hope that they will be able to deal quickly and effectively with Brendyl and either resume possession of the restaurant or pursue a sale.

9. Pursuant to Bankruptcy Rule 1007(d), lists containing the names and addresses of the known creditors holding the twenty (20) largest unsecured claims against the Debtors are attached to the Petitions.

10. 41 Murray has two (2) secured creditors identified as follows:

- (i) New York Business Development Corporation holds a consolidated mortgage previously held by New York Business Development Corp. and Empire State Certified Development Corporation in total outstanding amount of approximately \$1,988,917.99; and
- (ii) World Trade Center Business Recovery Fund, Inc. extended 41 Murray a working capital loan guaranteed by Debtor's personal property and fixtures with total outstanding amount of approximately \$136,581.59.

11. Amarach is co-obligated with 41 Murray on the working capital loan obtained from World Trade Center Business Recovery Fund, Inc.

12. The Petitions each contain a matrix of all known creditors.

13. As listed in the accompanying schedules, 41 Murray's primary assets are the Property and operating bank account which, as of August 31, 2011, held a balance of \$49,725. 41 Murray also has an outstanding account received in the amount of approximately \$120,000 for unpaid rent owed by Brendyl. Amarach's primary assets are the restaurant fixtures, equipment and furniture valued at approximately \$100,000. Amarach also holds a New York State Liquor Authority license. In addition to the secured debt noted above, 41 Murray owes approximately \$15,000 in taxes to the New York State and about \$64,000 in unsecured debt. Amarach owes approximately \$10,000 in taxes to the New York State and about \$13,000 in general trade debt.

14. The Debtors both have the same two members—myself and Catherine O’Toole (as Administratrix of the Estate of Seamus O’Toole, deceased) with each member owning a 50% interest in each of the Debtors.

15. There is no property of the Debtors in the possession or custody of any third party, with the exception of Brendyl.

16. All of the Debtors’ physical assets are located at the Property. Certain records are in the possession of the Debtors’ accountant, Valentine Longano CPA of Longano & Berger LLP, at his offices at 2171 Jericho Turnpike, # 338, Commack, New York.

17. The Debtors are both parties to the two litigations listed in the Petitions. One litigation was commenced in Supreme Court, New York County by New York Business Development Corporation and Empire State Certified Development Corporation (Index No. 850022/2011). The other action was commenced in Supreme Court, New York County by World Trade Center Small Business Recovery Fund, Inc. (Index No. 102216/2011).


18. I am the managing member and 50% interest holders in each one of the Debtors. After the death of Seamus O’Toole, Catherine O’Toole, as administratrix of Mr. O’Toole’s estate, has been the other 50% members of each one of the Debtors.

19. The Debtors have no employees.

20. The members of the Debtors do not receive a salary.




