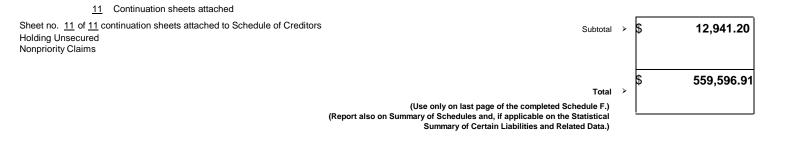

3. The Debtors are a creative boutique offering audio mixing and sound design, video editing, post production, design, graphics and animation services. Their studio is located at 1375 Broadway, 7th Floor, New York, New York (the "Premises").

4. Bionic provides worldwide creative services to major television networks, advertising agencies and corporate companies. Bionic currently employs thirteen creative professionals.

5. Keyframe is the lessee of the Premises and the owner of the vast majority of the equipment necessary to operate Bionic's businesses.

6. The Debtors' Secured Creditors are as set forth on Schedule D annexed to the Debtors' Voluntary Petition.

7. The names and addresses of the twenty largest unsecured creditors of each of the Debtors, excluding insiders, appears on Schedule "A" to this Affirmation.

9. The purpose of filing these petitions is to provide for the orderly sale of the Debtors' business as a going concern which will result in a maximization of return to the Debtors' secured creditors, who have undersecured liens on all the Debtors' assets.

10. The estimated amount of payroll due to the Debtors' employees, excluding officers, for a period of thirty days following the filing of the petition is \$0. Since May 1, 2012, the Debtors' 13 employees have agreed to work without pay and are working in a significantly reduced capacity.

11. The Debtors' estimated income and expenses for the next thirty days is: \$25,000 of income and \$44,000 of rent expense and \$3,500 of insurance expense..

12. The Debtors' financial difficulties were caused by, amongst other things, the general economic climate. In the fall and winter of 2011, a competitor poached three main employees of the Debtors. These employees comprised the near entirety of the Debtors' sound mixing and video editing business and commanded a client base that accounted for roughly one-third of the Debtors' revenues. By March 2012, nine more employees left the Debtors, resulting in a significant decline in revenue causing the Debtors to have insufficient funds to pay expenses.

13. The Debtors have made no public offering of their securities and no securities issued by the Debtors are publicly held.
