- 3. The Debtors are a creative boutique offering audio mixing and sound design, video editing, post production, design, graphics and animation services. Their studio is located at 1375 Broadway, 7th Floor, New York, New York (the "Premises").
- 4. Bionic provides worldwide creative services to major television networks, advertising agencies and corporate companies. Bionic currently employs thirteen creative professionals.
- 5. Keyframe is the lessee of the Premises and the owner of the vast majority of the equipment necessary to operate Bionic's businesses.
- 6. The Debtors' Secured Creditors are as set forth on Schedule D annexed to the Debtors' Voluntary Petition.
- 7. The names and addresses of the twenty largest unsecured creditors of each of the Debtors, excluding insiders, appears on Schedule "A" to this Affirmation.
- 8. To the best of my knowledge, the only pending suits by or against the Debtors are:
 - (a) BIONIC MEDIA, LLC v. ZILO NETWORKS, INC. MCLAREN, CAMPBELL, NEW YORK COUNTY CIVIL COURT, INDEX NO. 001882/2010;

9. The purpose of filing these petitions is to provide for the orderly sale of the

Debtors' business as a going concern which will result in a maximization of return to the

Debtors' secured creditors, who have undersecured liens on all the Debtors' assets.

10. The estimated amount of payroll due to the Debtors' employees, excluding

officers, for a period of thirty days following the filing of the petition is \$0. Since May 1, 2012,

the Debtors' 13 employees have agreed to work without pay and are working in a significantly

reduced capacity.
