Sam Dushey, declares the following under penalties of perjury pursuant to 28 U.S.C. § 1746:

- 1. I am the Manager of XSRE Paramus, LLC (the "Debtor"), and I submit this Declaration in accordance with Local Bankruptcy Rule 1007-2 in support of the Debtor's filing of a voluntary petition ("Petition") under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code").
- 2. The Debtor is a real estate holding company, which holds a ten-year commercial lease (the "Lease") dated October 18, 2010 (plus renewals) for a retail store in the Paramus Town Square located at 240 Route 17 North in Paramus, New Jersey 07652 (the "Paramus Store").
- 3. The Debtor is also the wholly owned subsidiary of XSRE Retail Group, LLC ("XSRE Retail Group"), which operates various women's accessories stores under the trade name "XSRE". As with all of the stores in the XSRE chain, XSRE Retail

Group owns the inventory at each location, including the Paramus store, and pays for all of the operating expenses and payroll. Conversely, the Debtor only holds the lease for the Paramus Store and receives funds from XSRE Retail Group to pay the rent due thereunder.

- 4. This petition is filed following months of litigation in the State Court with the Debtor's landlord, Faber Bros., Inc. (the "Landlord") over a variety of issues. At this point, most of the litigation has now ended, and the Debtor has paid all rent due under the Lease through November, 2012. The only matter still pending is the Landlord's request for attorneys' fees in the sum of \$70,687.70.
- 5. With the Christmas season in full swing, the Debtor is at a crossroads concerning the future of Paramus Store. In an effort to avoid the closure of the location, the Debtor hopes to utilize Chapter 11 as a last opportunity to negotiate a modified lease or sublet arrangement with the Landlord that will allow the store to continue.
- 6. The Lease requires total monthly rent of \$58,185.00 including taxes and CAM. This rent rate has proven too expensive for the Debtor and XSRE, and is believed to be well above market rate for any retailer.
- 7. Other than the Landlord, XSRE Retail Group, and its attorneys in the State Court, the Debtor has no other creditors.
- 8. The Debtor's assets consist of the lease and significant leasehold improvements contributed by XSRE Retail Group to fixture and open the Paramus Store.

- 9. There is no property of the Debtor in the possession of any third party.
- 10. The Debtor's books and records are maintained at the executive offices of XSRE Retail Group in New York City.
- 11. The Debtor has no employees. I am the sole manager of the Debtor and draw my salary from XSRE Retail Group. The only expense that will be incurred by the Debtor in the first thirty days of the bankruptcy case is rent of \$58,185 per month.
