





AFFIRMATION PURSUANT TO LOCAL BANKRUPTCY RULE 1007-2

JAMES ROGAN, hereby affirms as follows:

1. I am the managing member and sole owner of ROGAN RR, LLC , a New York Corporation (“Rogan” or the "Debtor"). I have served in these positions since or about 2005 when it was founded. I submit this affirmation pursuant to Federal Rule of Bankruptcy Procedure 1007(d) and Local Bankruptcy Rule 1007-2.

2. Rogan is in the business primarily of owning a yard at 225 Railroad, Avenue Bedford Hills, NY (the “Premises”).

3. The Premises is occupied by a waste disposal business which is owned by my former wife Ada Roldan.

4. Rogan acquired the Premises in or about 2005 from Finne Brothers, an entity which was the subject of a Chapter 11 proceeding. As part of the acquisition, Rogan assumed the existing mortgage with Eastern Savings Bank ("Eastern"). Upon information and

belief, the balance due is approximately \$700,000.00.

5. Unfortunately, it appears that the assumption paperwork was not properly filed. Although I was paying Eastern, it imposed an onerous default interest rate. When I contacted Eastern regarding the questionable rate, its representative indicated that it had no record of the assumption.

6. Rogan ultimately stopped paying the mortgage. Eastern commenced a foreclosure action.

7. Rogan filed to avoid the imminent seizure of the Premises at a foreclosure sale.

8. Rogan hopes to retain the Premises and emerge from Chapter 11 either through a resolution with Eastern, by refinancing, or by an infusion of capital from a potential business partner.

9. The Debtor has limited creditors which include Eastern and a junior mortgage holder, George Paletta.

10. The Debtor has no employees.

11. This case was not originally commenced as a Chapter 7 proceeding.

12. During the next 30 days, I estimate that gross receipts will be enough to make adequate protection payments to Eastern. Because the case was filed on an emergency basis just before the foreclosure sale, I was not able to make realistic projections.

Based upon the foregoing, it is submitted that Rogan's needs and interests will be best served by its continued possession and management of its business as a debtor-in-possession under Chapter 11.
