

**DECLARATION PURSUANT TO LOCAL BANKRUPTCY RULES**

Zvi Benjamin Zhavian declares the following under penalties of perjury pursuant to 28 U.S.C. § 1746:

1. I am the member/manager of 77-79 Rivington Street Realty, LLC (the “Debtor”). I submit this Declaration pursuant to Rule 1007-2 of the Local Bankruptcy Rules, to provide background information regarding the Debtor’s business, the circumstances prompting the Chapter 11 filing, the Debtor’s assets and capital structure, and the Debtor’s strategies for reorganization.

**(A) The Debtor’s Business**

2. The Debtor is a New York limited liability company which owns certain commercial real property at 77-79 Rivington Street, New York, NY, consisting of two adjoining parcels (collectively, the “Property”). The first parcel (Block 415, Lot 61) consists of a mixed-use commercial building with 16 residential units and a ground floor commercial space. The second parcel (Block 415, Lot 62) is currently vacant open air space, but presents an ideal development site, either as an extension of the existing commercial premises, or as a part of a greater development involving the adjoining Allen Street Hotel Project (139-141 Orchard Street), which is owned by an affiliate of the Debtor, D.A.B. Group, LLC.

3. The Property is subject to a first mortgage lien (the "Mortgage"), currently held by BNH Rivington, as successor to Signature Bank (the "Lender"). The Mortgage is in arrears and subject to pending state court foreclosure proceedings. The Property has also been in the possession of a Receiver, Scott Weingarten, since early 2012.

**(B) Material Events Leading up to the Bankruptcy Filing**

4. The direct impetus for the Chapter 11 filing is the implications of the pending foreclosure action. The Lender is seeking entry of a Judgment of Foreclosure, which includes more than \$2.0 million dollars of default interest at a charged rate of 24% per annum. The default rate of interest is four times (400%) the regular amount of the non-default rate of six percent (6%), and carries all of the earmarks of a penalty. The Debtor intends to challenge the validity of the default rate in bankruptcy.

5. The underlying principal balance owed under the Mortgage remains at relatively manageable levels of \$4,872,366.03. Thus, the great disparity between the regular non-default interest rate and the default rate will be a major focus of the bankruptcy, since the Debtor's ultimate ability to make a distribution to other creditors is likely dependent on obtaining relief in connection with the allowability of default interest.

**(C) Assets and Capital Structure**

6. Pursuant to Bankruptcy Rule 1007(d), a list containing the names and addresses of the creditors holding the twenty (20) largest unsecured claims against the Debtor is attached to this Petition as Exhibit "1".

7. The Debtor's secured creditors are listed in the accompanying bankruptcy schedules and consist primarily of the Lender's Mortgage claim.

8. For purposes of the bankruptcy, the Debtor estimates that the Property will have a stabilized fair market value of approximately \$7.0 million, or more. This value is based upon the belief that significant additional rental income can be derived from the development of the vacant adjoining parcel at 79 Rivington Street.

9. Indeed, the Debtor projects that when the Property is fully developed, it can generate gross rents of approximately \$45,000 per month. The current rents are approximately \$30,000 per month because the commercial space is sorely under-utilized.

**(D) Reorganization Strategy**

10. The Debtor's overall reorganization strategy is still being developed, but will center upon regaining possession of the Property from the Receiver. Thereafter, the Debtor intends to utilize all reasonable efforts to develop 79 Rivington Street to maximize income from the commercial space.

11. The Debtor intends to challenge the Lender's entitlement to default interest, so that refinancing of the Mortgage can be pursued, either from outside sources, or internally pursuant to an extended term, with post-confirmation interest to be established in accordance with the Supreme Court principles.

12. During the Chapter 11 case, the Debtor also intends to resume debt service payments in accordance with 11 U.S.C. § 362(d)(3).


