

1. I am the CEO of **New Creators Inc. d/b/a Sushi Sasabune NY** (the “Debtor”), and am fully familiar with the facts set forth herein.
2. The Debtor operates a restaurant in New York, New York.
3. No pre-petition committee was organized prior to the Order for relief.
4. The Debtor does not have any secured creditors.




