FURTHER ORDER EXTENDING TIME TO CONFIRM SMALL BUSINESS PLAN, EXTENDING USE OF CASH COLLATERAL AND ESTABLISHING DATE FOR FURTHER HEARING

This matter having come before this Court on September 20, 2017 for a further status conference regarding the Debtors' efforts to confirm the Debtors' "Amended Combined Joint Disclosure Statement and Chapter 11 Small Business Plan of Reorganization/Liquidation of 5 Star Washer Technical Services, Inc. and Stacy F. Spears," filed January 12, 2016 (the "Plan"), and regarding the motion of the Debtors, as set forth in the Plan, requesting the entry of an Order, pursuant to 11 U.S.C. §§ 1121(e)(3) and 1129(e), extending the time for confirming the Debtors' Plan, and regarding the Debtors' further request for continuing authorization to use cash collateral,

AND, counsel for the Debtors having advised the Court that the Debtors' efforts to pursue those asset sales contemplated by the Debtors' Plan are continuing, however, additional time is needed to complete those efforts,

NOW, upon all pleadings and proceedings had in this matter to date, and good cause appearing therefor, it is hereby

ORDERED, that the Debtors' time to confirm their Small Business Plan is hereby extended through December 31, 2017; and it is

ORDERED, that the Debtors are hereby authorized to continue to use cash collateral through December 31, 2017, on those same terms set forth in this Court's Twentieth Interim Order Authorizing Use of Cash Collateral entered on January 13, 2016 [Docket No. 439]; and it is

ORDERED, that a further hearing and status report on confirmation of the Debtors' Plan and on approval of any further extension of both the time to confirm the Debtors' Small Business Plan and the Debtors' continued use of cash collateral beyond December 31, 2017 will be held on December 13, 2017, at 10:00 a.m., at the United States Bankruptcy Court, Part I, Olympic Towers, 300 Pearl Street, Third Floor, Buffalo, New York 14202-2501.
