Please be advised that the law firm of **Miller, Luring, Venters & Wesner Co., L.P.A.** will undertake representation as counsel of the company at the employment rate of \$200.00 per hour plus all expenses. The current billing rate for Roger E. Luring is \$200.00 per hour.

The company recognize that the firm's right to receive payment is not subject to the financial

problems of the company, if any. The company acknowledges in the event of nonpayment of the firm's invoices timely made, that the firm will withdraw as counsel of record, subject to Court approval for any cases wherein the firm has appeared as counsel of record for the company.

The company recognizes that the firm represents only the company, and specifically not any of the shareholders, directors, officers and/or any other individuals. The company acknowledges that while discussions may come up from time to time regarding the impact of the bankruptcy of the company upon individuals, that the individuals cannot rely on any representations made by the firm as to the impact upon them, as each individual must look to his/her own firm/attorney for representation as to the consequences of the bankruptcy of the company upon such individual.
