**BALLOT FOR ACCEPTING OR REJECTING  
PLAN OF REORGANIZATION**

On June 2, 2017, World Imports, Ltd., World Imports South, LLC and World Imports Chicago, LLC (the "Debtors") and the Official Committee of Unsecured Creditors of the Estate of World Imports, Ltd. (the "Committee") filed a Joint Plan of Reorganization (the "Plan"), which Plan is referred to in this Ballot. The Bankruptcy Court may confirm the Plan if the Plan is accepted by the holders of two-thirds (2/3) in amount and more than one-half (1/2) in number of claims in each class actually voting on the Plan. In the event that the requisite acceptances are not obtained, the Bankruptcy Court may, nevertheless, confirm the Plan if the Bankruptcy Court determines that the Plan is fair and equitable in its treatment of the claims in the rejecting class.

**IN ORDER FOR YOUR VOTE TO COUNT,  
YOU MUST COMPLETE AND RETURN  
THIS BALLOT**

The claims against the Debtors have been divided into various classes according to the type of claim. As a result, you may have claims in more than one class. For example, you may be an unsecured creditor holding an unsecured claim as well as the holder of an administrative, or other priority or secured claim. You may wish to consult with your legal advisor to determine which class of claims your claim belongs in or whether you have claims in more than one class and, if so, which classes. To assist you and your legal advisor, the following classification are the classes of claims eligible to vote under the provisions of the Plan. The following is being provided in order to assist you and your legal advisor in determining what class of claims your claim belongs in and/or whether you have claims in more than one class.

CLASS 1. Class 1 consists of the Claims of OEC.

CLASS 2. Class 2 consists of Allowed Priority Non-Tax Claims of ex-employees of the Debtors relating to unpaid vacation and sick time even though such Claims may become Allowed Claims after the Effective Date.

CLASS 3. Class 3 consists of priority tax claims of governmental units under Section 507(a)(8) of the Bankruptcy Code.

CLASS 4. Class 4 consists of the General Unsecured Claims, even though such Claims become Allowed Claims after the Effective Date.

CLASS 5. Class 5 consists of holders of common stock in the Debtors even though such Claims may become Allowed Claims after the Effective Date.

If you have claims in more than one class, make the appropriate number of photocopies of this Ballot and complete one Ballot for each class of claim you have.
