The undersigned, being the Managing Member of CES Gastonia LLC, a Delaware limited liability company (the "**Company**"), hereby consents in writing to the adoption of the following resolutions (the "**Resolutions**") and the taking of the actions described therein.

WHEREAS, the Company is managed under the direction of CE Sportz LLC, as Managing Member of the Company (the "Manager");

WHEREAS, the Manager has reviewed and considered materials presented by legal and financial advisors of the Company and management regarding the Company's financial and operating difficulties and the impact of the foregoing on the Company's businesses and its stakeholders;

WHEREAS, the Manager has received and considered advice from the legal and financial advisors of the Company and management regarding possible strategic alternatives to address the Company's financial and operating difficulties, including pursuant to in-court bankruptcy proceedings, and the impact of the foregoing on the Company's business and its stakeholders;

WHEREAS, in light of the foregoing, the Manager has determined that it is in the best interests of the Company and its stakeholders that the Company consummate its restructuring pursuant to chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"); and

WHEREAS, the Company does not have sufficient liquidity to operate in a chapter 11 bankruptcy proceeding and the Manager has therefore determined that it is in the best interests of the Company and its stakeholders to (i) obtain postpetition financing (the "DIP Facility") pursuant to that certain debtor in possession credit agreement by and between Atalaya Capital Management, LP (the "DIP Lender") and the Company (the "DIP Credit Agreement") and (ii) grant a security interest in the Company's assets to the DIP Lenders to secure the obligations under the DIP Facility, all as provided in the DIP Credit Agreement.
